## LICENSE AUTHORIZATION

- □ I am currently licensed as a New York State Professional Engineer (PE) and has completed a Department-approved 8-hour Site Safety Course within one (1) year prior to application date, and a 10-hour Occupational Safety and Health Standard Construction Industry Course within two (2) years immediately preceding the date of application; or
- □ I am currently registered as a New York State Registered Architect (RA) and has completed a Department-approved 8-hour Site Safety Course within one (1) year prior to application date, and a 10-hour Occupational Safety and Health Standard Construction Industry Course within two (2) years immediately preceding the date of application; or
- □ I have a Construction Health and Safety Technician (CHST) designation from the Board of Certified Safety Professionals (BCSP) and has completed a Department-approved 8-hour Site Safety Course within one (1) year prior to application date, and a 10-hour Occupational Safety and Health Standard Construction Industry Course within two (2) years immediately preceding the date of application; or
- □ I have five (5) years of experience within the last ten (10) years as a Building Code Enforcement Official charged with the enforcement of the provisions of the New York City Building Code, and has completed a Department-approved 8-hour Site Safety Course within one (1) year prior to application date, and a 10-hour Occupational Safety and Health Standard Construction Industry Course within two (2) years immediately preceding the date of application. The enforcement must have included inspections of buildings under construction or demolition and thus this basis for qualification excludes officials whose primary role is to perform inspections of occupied or vacant buildings; or
- □ I have five (5) years of full-time experience within the last ten (10) years as a safety official for a government entity or construction firm, or as a safety manager or safety engineer for a consulting firm

which specializes in construction or demolition, and has completed a Department-approved 8-hour Site Safety Course within one (1) year prior to application date, and a 10-hour Occupational Safety and Health Standard Construction Industry Course within two (2) years immediately preceding the date of application; or

- □ I have five (5) years of full-time experience within the last ten (10) years working with plans within a relevant construction trade in furtherance of the construction, vertical or horizontal enlargement, or the full demolition of a building or structure, and has completed a Department-approved **40-hour** Site Safety Course within one year prior to application date, and a 10-hour Occupational Safety and Health Standard Construction Industry Course within two (2) years immediately preceding the date of application; **or**
- □ I have equivalent education and construction experience with one of the qualification bases listed above and as outlined in RCNY 3301-02(e)(3). I have also completed a Department-approved 8-hour or 40-hour Site Safety Course within one year prior to application date, and a 10-hour Occupational Safety and Health Standard Construction Industry Course within two (2) years immediately preceding the date of application. Each year of formal training or education in a program with emphasis on construction at a college, technical or trade school may be substituted for one (1) year of construction work up to a maximum of three (3) years.
