

## **Local Law 53 Annual Report Calendar Year 2021**

This report details the number of noise inspections, with a focus on the number of noise complaints received by the Department of Environmental Protection (DEP) related to afterhours noise complaints and response time to those complaints as well as the number of summonses issued.

The answers below describe the status of the DEP's implementation of the law and respond to the specific questions posed in the legislation.

1. What is the number of inspectors employed by the department?

There are 71 (68 on board and 3 vacancies) Air and Noise Inspectors.

2. What is the number of complaints regarding noise received by the department, disaggregated by the type of noise?

3. What is the number of after-hours noise complaints responded to within the amount of time prescribed by rule as well as the number of duplicative after-hours noise complaints?

There were 4,419 duplicative after-hours noise complaints. All after-hours noise complaints follow the prescribed protocol which is contained at the end of the document.

There were 45,076 complaints that did not result in a summons for complaints in CY 2021.
