







CERTIFICATE 23425

RESOLVED That the Design Commission, having considered designs for the construction of the FDNY Marine Company 9 Firehouse, Homeport Pier at Baltic Street, Stapleton, Staten Island, submitted by the Economic Development Corporation and the Fire Department, represented by exhibits 6835-O, P, Q, R & S of record in this matter, hereby gives to the same unanimous preliminary approval subject to (1) using a bright red glossy material for the upper portion, noting that the bright "fire engine" red color is critical to the building's success, and the proposed terra cotta color is unacceptable; (2) utilizing a different material for the white bottom portion; (3) restudying the signage and developing a standard using a sans serif font more in keeping with the graphics proposed for Engine Company 160 and Rescue Company 5's garage in Staten Island; (4) submitting a lighting plan; and (5) retrofitting catch basin inserts for the French drains to address the Department of Environmental Conservation's concerns. The Commission recommends that the architect explore porcelain enamel, which is high gloss, self cleaning and comes in large panels to minimize joints, or another material, such as Eternit's Swisspearl, with integral color (rather than a surface application) and cautioned against terra cotta, even in the custom red, as it tends to chip. The Commission commends the Fire Department, and notes that it looks forward to reviewing preliminary designs for the park, revised in consultation with the Department of Parks & Recreation, and an update on the development component when the Economic Development Corporation resubmits the Stapleton Waterfront for review in fall 2009.

RESOLVED That the Design Commission, having considered designs for the construction of a waterfront park, Ferry Point Park, south of the golf course, Whitestone Bridge approach, Emerson Avenue, the East River, Bronx, submitted by the Department of Parks & Recreation, represented by exhibits 2227-BV, BW & BX of record in this matter, hereby gives to the same unanimous preliminary approval with the understanding that the Parks Department will address the following comments with regard to the vehicular access road to the waterfront park: (1) as part of the approved golf course design, plant *Celtis occidentalis* 'Magnifica' along the vehicular access road, in lieu of the Red Maples that will be relocated to an alternate site that is not along a roadway, which requires salting in the winter months, and submit revised drawings for committee review; and (2) once a concessionaire is brought on board for the clubhouse design, submit for committee review at the conceptual level a comprehensive wayfinding signage program that clearly announces this public amenity beyond the concession, likely necessitating more signage along the vehicular access road than currently shown.



RESOLVED That the Design Commission, having considered designs for the construction of a comfort station, rain shelters and a maintenance building, Ferry Point Park Golf Course, Balcom Avenue, Miles Avenue, Whitestone Bridge approach, the East River, Bronx, submitted by the Department of Parks & Recreation, represented by exhibits 2227-BY, BZ, CA, CB & CC of record in this matter, hereby gives to the same unanimous preliminary and final approval subject to (1) utilizing the metal paneling in Terra Brown for the entire maintenance structure, including the façades, except for all doors, which should be the same material in a tan color, and (2) submitting two comprehensive sets of final drawings that incorporate this revision, but otherwise reflect the approved schematic designs.

Approval is also given with the understanding that (1) as the Parks Department confirmed, the exterior materials for the comfort station and rain shelters will not be compromised by value-engineering and/or due to single-sourcing; (2) the Parks Department will select an architect for the clubhouse from the Design Excellence list to ensure the highest standards of design for the building, which must be coordinated with the design of the non-concession buildings; and (3) the selected concessionaire will be responsible for providing wayfinding signage for the golf course, which will be submitted for review in spring 2010 as part of the clubhouse package. 

The Commission notes that (1) the proposal does not restore the historic entrance alignment in which a stoop projected beyond the property line, but rather the entrance has been reconstructed at-grade; (2) the proposed fence would create a pinch-point on the public sidewalk at the existing tree pit; and (3) the public sidewalk should not be encroached upon for private use by the addition of a fence to accommodate garbage cans.


