RESOLVED That the Design Commission, having considered designs for the installation of a distinctive sidewalk, W. R. Grace Building, 1114 Avenue of the Americas, West 42<sup>nd</sup> and West 43<sup>rd</sup> Street between Avenue of the Americas and Fifth Avenue, Manhattan, submitted by the Department of Buildings, represented by exhibits 5952-E, F, G, H & I of record in this matter, hereby gives to the same unanimous preliminary and final approval to the travertine sidewalk at the West 42<sup>nd</sup> Street entrance, which was part of Gordon Bunshaft's original design, given the significance of the building to the history of modern architecture in New York City. The Commission rejects the distinctive concrete treatment proposed for West 43<sup>rd</sup> Street and Avenue of the Americas, but notes that it would consider the standard grey tinted concrete for commercial districts with distinctive 4' x 4' scoring to match the plaza provided the treatment continues south on Sixth Avenue and east on 42<sup>nd</sup> Street, completing the block.
