Twenty-eight (28) cases are still open pending further investigation.

HOW LONG HAVE THESE CASES BEEN OPEN?

The number of days open ranges from 6 days to 85 days. The average number of days open is 43.

HOW MANY OF THE AGENTS WITH OPEN FADO COMPLAINTS HAVE BEEN THE SUBJECT OF PRIOR COMPLAINTS?

There are eleven (11) agents with open FADO complaints that have been the subjects of prior complaints.
