This is the Renewal ("Renewal") to the Health Liaisons and Borough Nursing Directors Memorandum of Understanding Agreement ("Agreement") between the Department of Health and Mental Hygiene ("DOHMH") and the Department of Education ("DOE"), with an effective date of July 1st 2017. This Renewal is effective as of July 1st 2020.

WITNESSETH:

WHEREAS, it is the goal of DOHMH to improve the health of school age children, such as in the areas of immunization compliance, obesity, vision abnormalities, asthma, and the consequences of risk taking behaviors; and it is the goal of the DOE to strengthen the public health related services it provides to students by providing designated staff and program support to deal with health issues; and

WHEREAS, DOHMH has expressed an interest in assisting-DOE with providing these health-related services:

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Parties hereto agree as follows:

1. The title of the Agreement is changed from "Health Liaisons and Borough Nursing Directors" to "Regional Health Director & Health Services Liaisons."
2. The Parties agree to renew the Agreement for a period of one year. The Term of the Renewal is July 1st 2020 through June 30th 2021 ("Renewal Term").
3. The DOHMH shall reimburse DOE through Intra-City payment transfers in an annual amount not to exceed \$3,084,891 for Fiscal Year 2021 (from July 1, 2020-June 30, 2021), for actual costs related to services performed by DOHMH, in accordance with the budget for the Renewal Term, as detailed below.


