



107 Spring Street: Previous Proposed Elevation, October 17, 2023





107 SPRING STREET: PROPOSED MASTER PLAN CRITERIA & DETAILS



- 2" border painted with a trompe l'oeil effect, to look like an unpainted wood frame, with contrasting sign content, within approved sign square footage and location on façade.
- No regulation of content within the designated sign space, as recommended by staff at public hearing.
- Term of the master plan permit shall be 10 years.
- Exposed wall is approx. 1,700 sq ft
- Signs total approx. 170 sq ft
- Proposed signs are less than 10% of the total façade.








