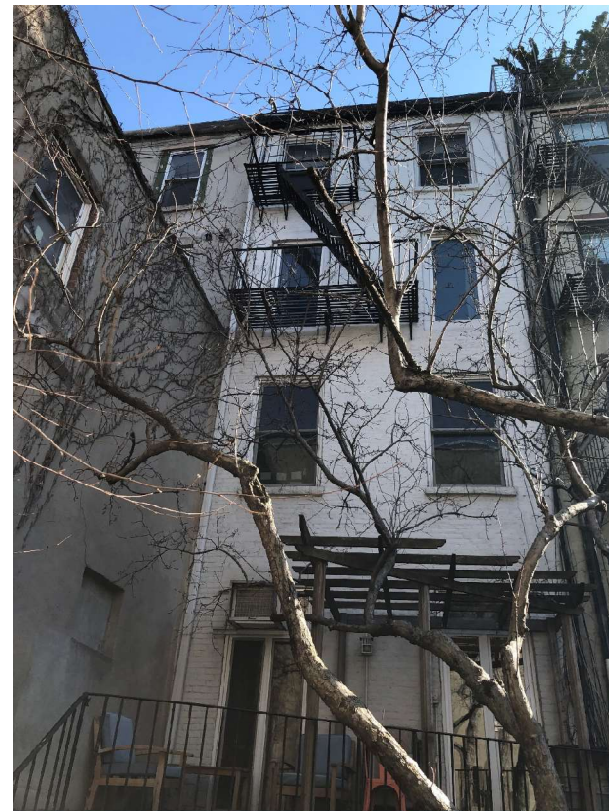

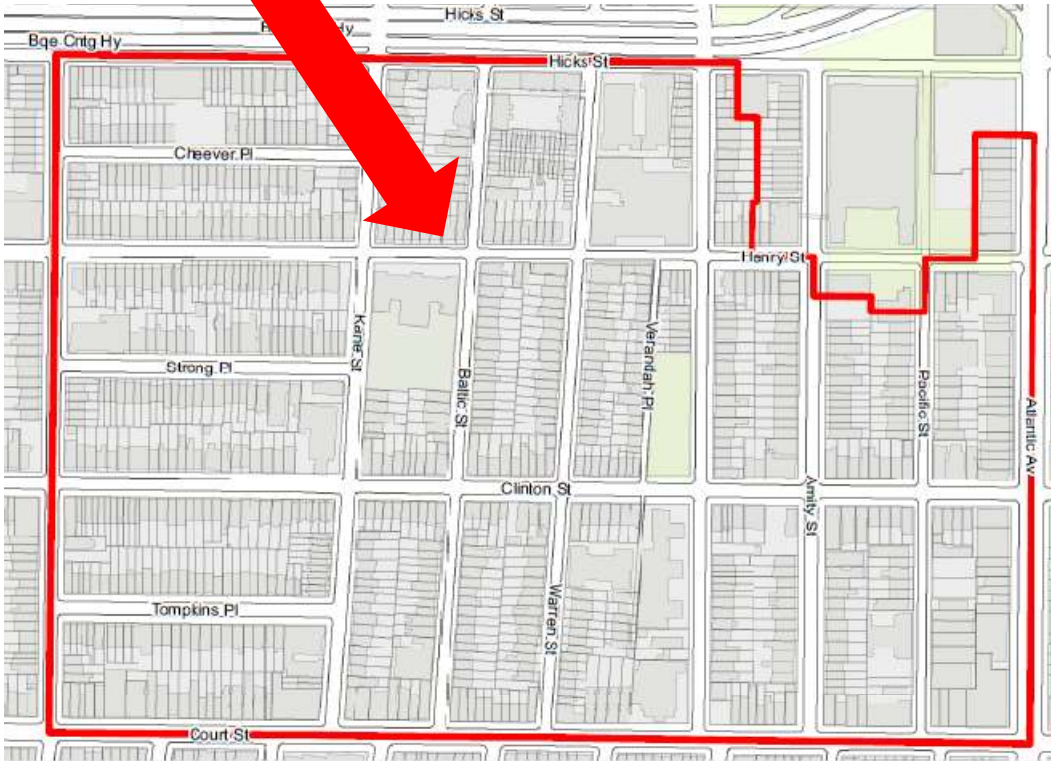

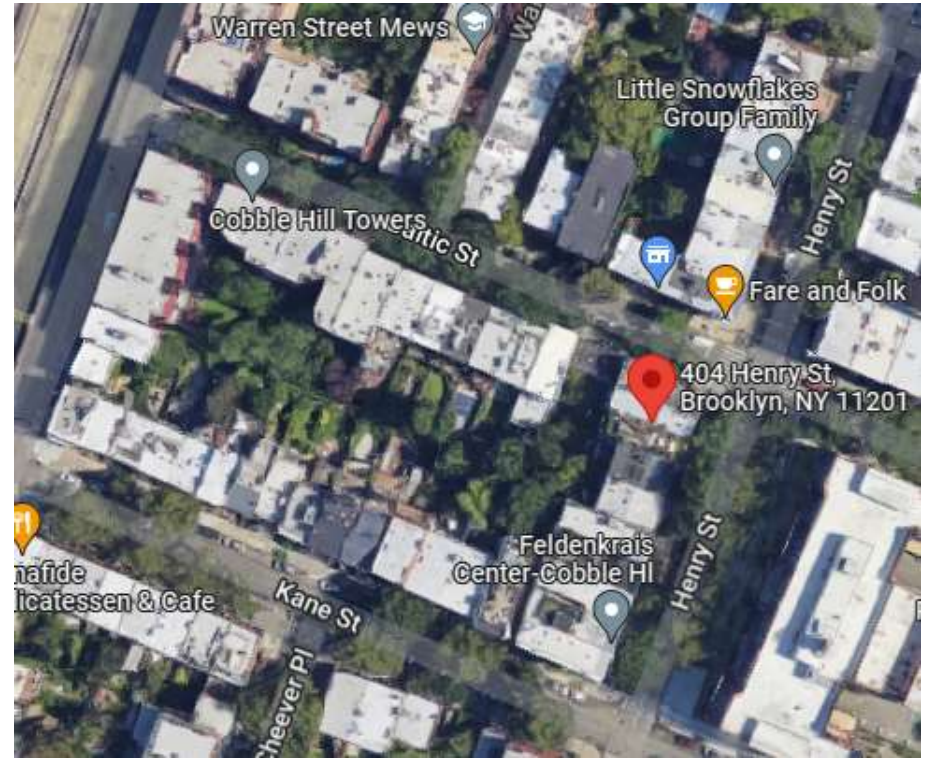


West (Rear) Picture of 404A Henry Street

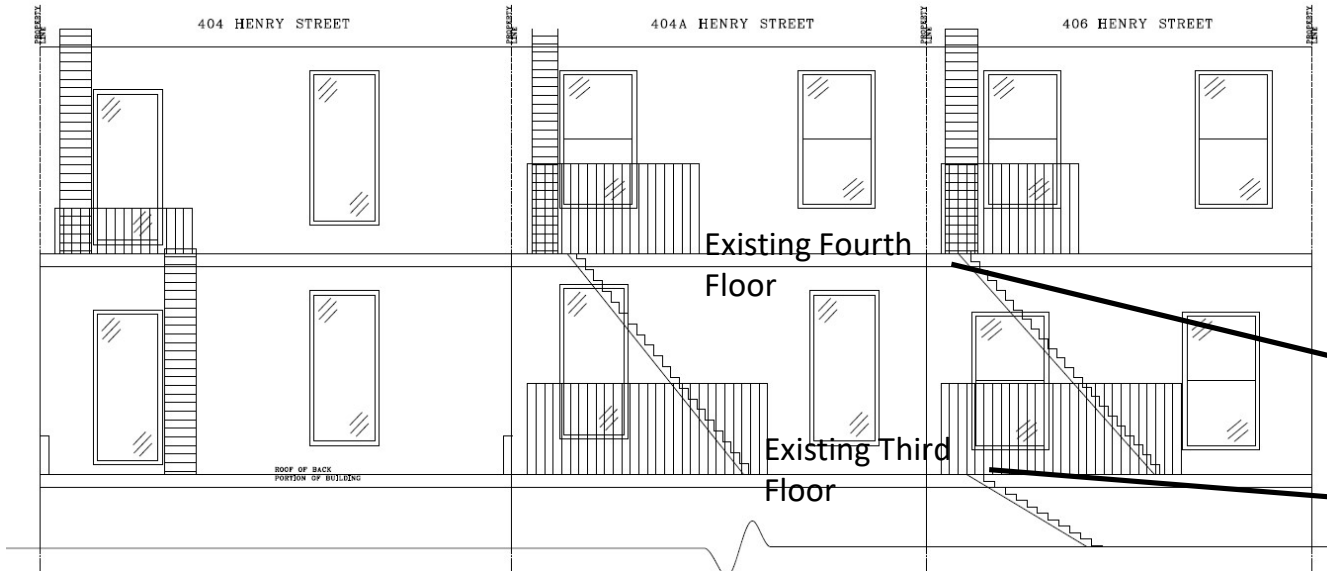

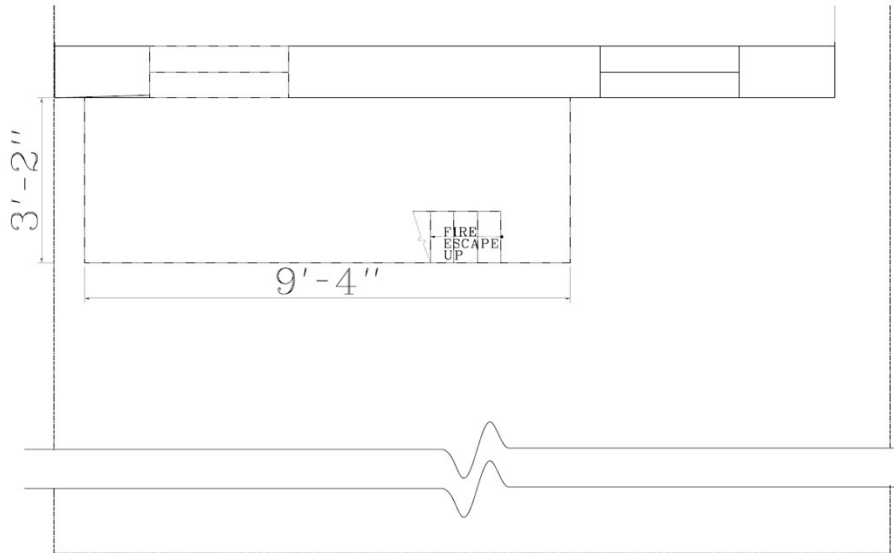

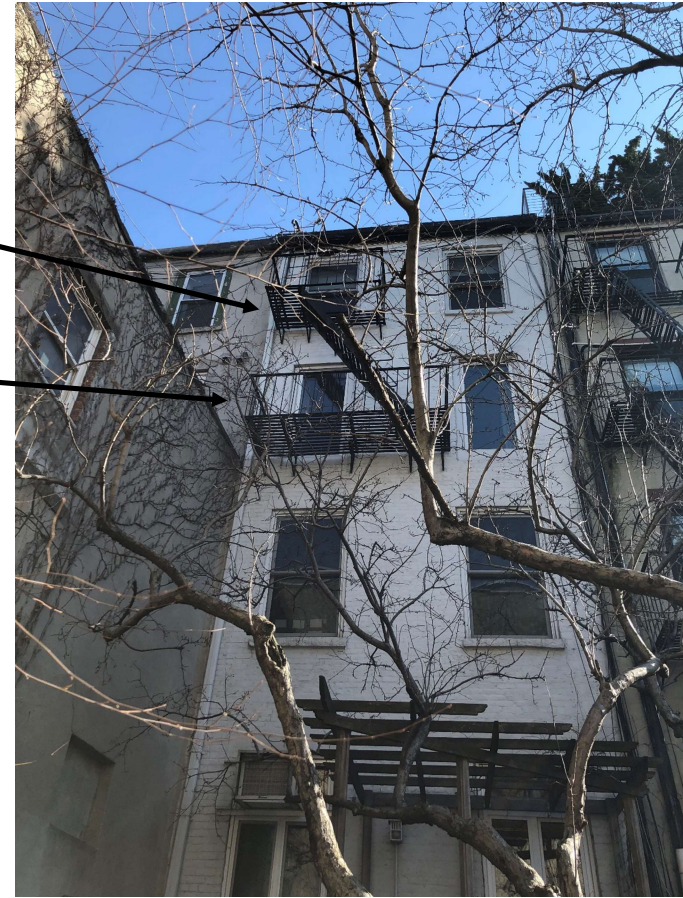

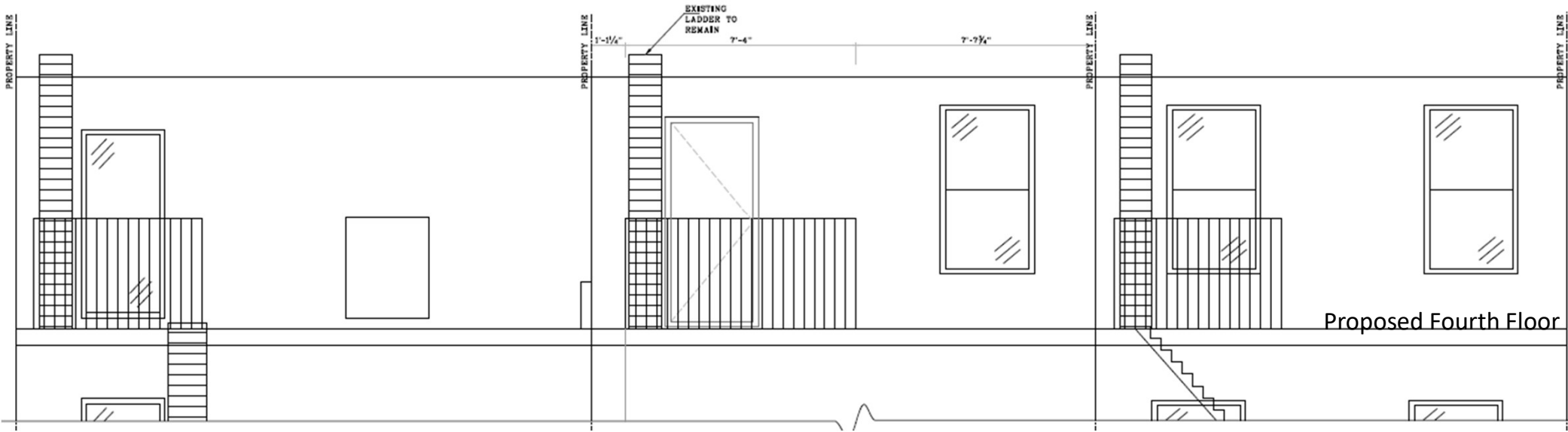


Existing Rear Elevation of 404, 404A, & 406 Henry Street

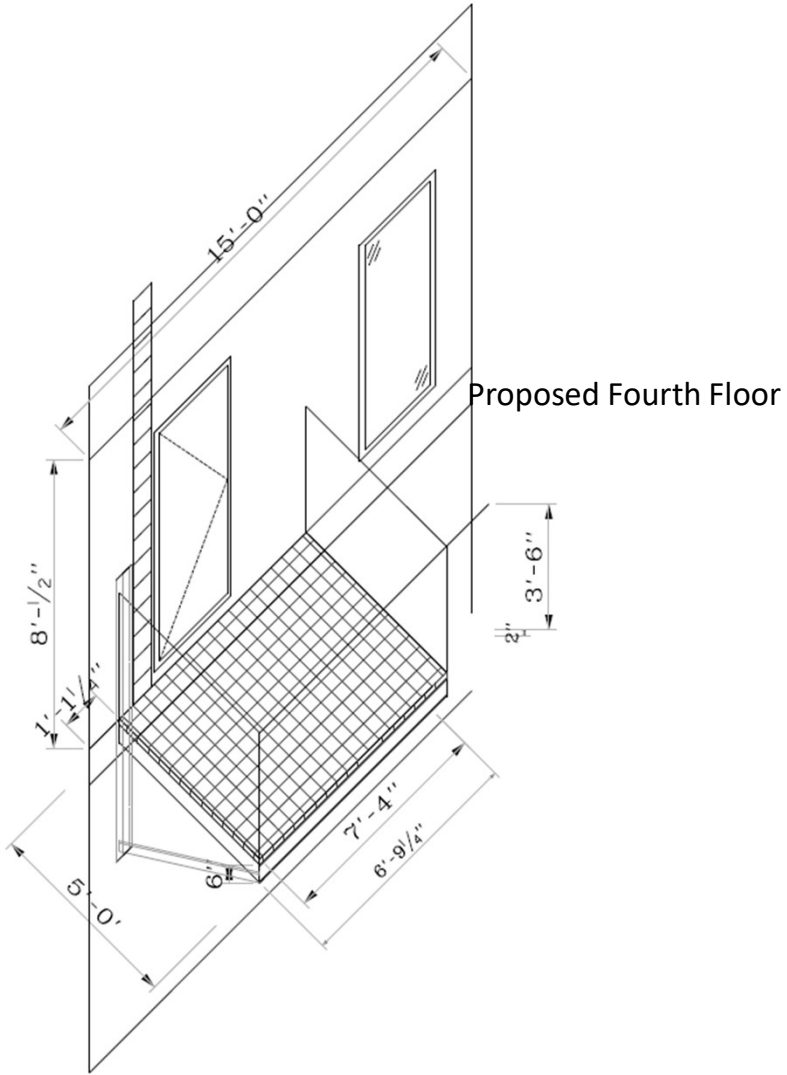


Existing Plan of Fire Escape

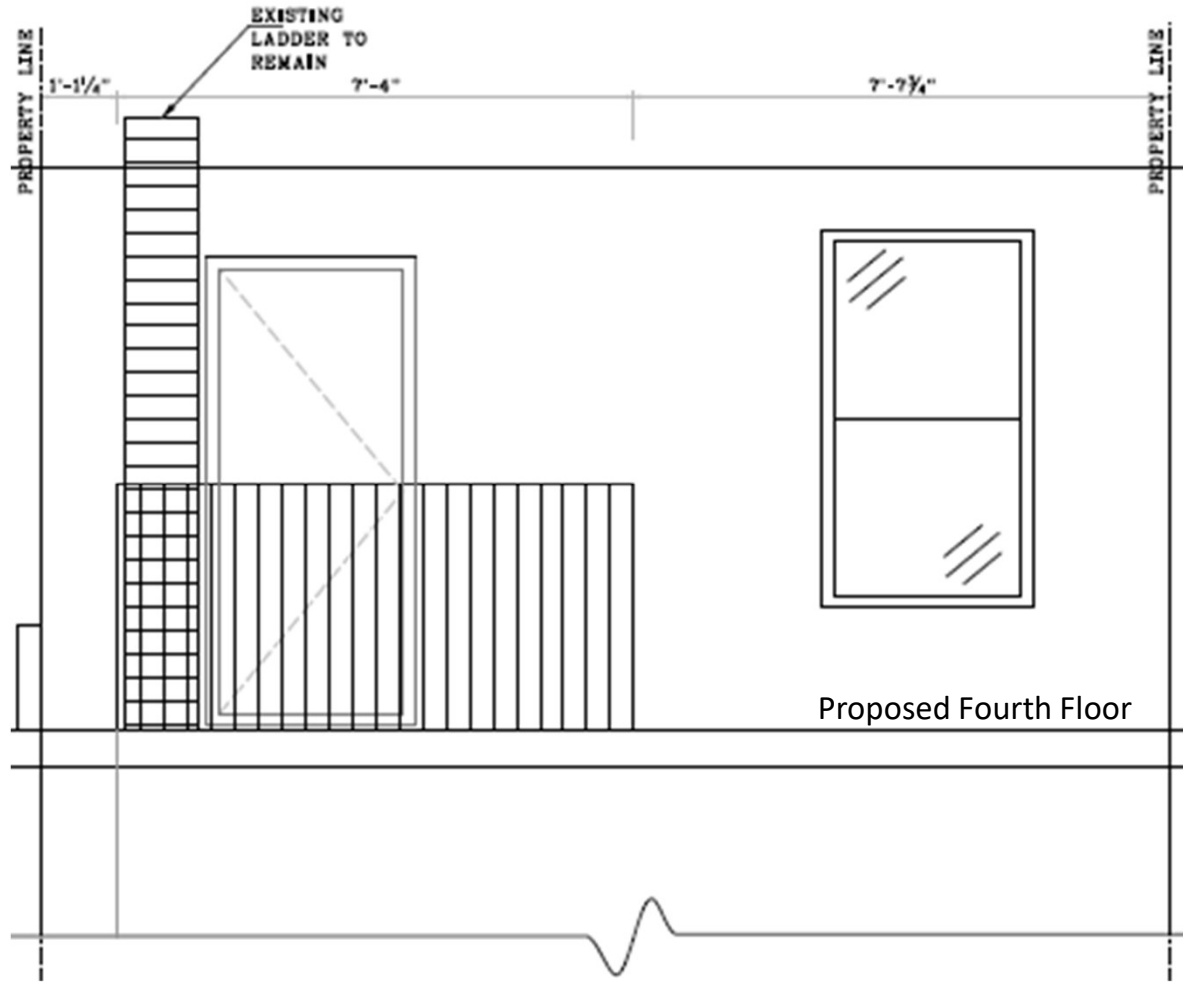
