Chairman Martin Prince began the meeting at 7:30PM with the Pledge of Allegiance.

The above Community Liaison representatives were introduced and thanked for coming.

- 5 Leon Tulton, Office of Assemblyman Benedetto: free income tax preparation for individuals 62 years and older until March 6; income limitation must be under 50K, Call 718-892-2235 or 718-320-2220 for an appointment.
- 6 Egidio Sementilli, resident of Pelham Bay: spoke of his opposition to the liquor license for 3607 E. Tremont Avenue.

A discussion among Board members about establishments serving liquor, covered topics from dancing, music, noise levels, and disruption in the neighborhoods where the establishments are located. Clarification was requested on the definition of a cabaret license, which is dancing. Many of the noise complaints that come into the 45<sup>th</sup> Precinct are found to be within the limits allowed by law. It was suggested that DEP be contacted regarding a possible change in the noise code. Chairman Prince advised the members that the Board will be meeting with the NYS Liquor Authority in the hopes of getting some guidance in dealing with the problem establishments.

The renewal of a liquor license for Havana Café was addressed. One of the establishment's owners stated that a neighboring property owner made numerous complaints, and threatened violence on several occasions. This resident filed complaints about the building prior to the opening of Havana, when it was an Italian restaurant. The NYPD has responded to the complaints and all have been satisfied; noise meter readings have been made and all were within range. The Board sent letters to the property owner and the business owners of Havana, requesting that a barrier be built to deflect noise along the back wall, which abuts private homes. One board member raised a concern that the noise issue has increased since Havana Café enlarged the establishment. An offer was made by one of the owners to personally meet with any complainant. The Board requested that any complaint be forwarded to the office.

Motion to close the Public Participation Section was made by Ms. Burrowes, seconded by Mr. Bieder and unanimously approved by all.

Motion to accept the minutes of the January 15, 2015 Community Board #10 meeting was made by Mr. Salimbene, seconded by Mr. Talarico and unanimously approved by all.

Council Member James Vacca addressed the Board meeting highlighting his efforts for the community and New York City, some of which include his opposition to the charge for plastic bags used in supermarkets; his opposition to eliminating the admissions testing for special high

schools, focusing instead on addressing the failure of middle schools to properly prepare students to take these exams; wants to see the surplus monies from the NYC budget be returned to taxpayers; freezing of water bills, real estate taxes (which are going to rise because of assessments); working on hiring more police for CPOP. In addition he added that he attended a meeting concerning the Ferry Service proposed for the Bronx, advocating the benefits to using CB #10 waterfront sites and was told that in the project's phase 2 this may be accomplished. He spoke about his frustration with city services, especially bus and sanitation. Lastly he voiced his concerns about granting liquor licenses to two new establishments – Casa and Illusions.

- NYC Build It Back program will return to the Board office, to work with homeowners who had registered, but did not complete paperwork to receive assistance as a result of Superstorm Sandy.
- NYS Dept. of Labor representative has returned to the Board office on Wednesdays. Representative Stephany Dawson has worked with the Board for approximately six months assisting individuals with resume writing, job searches, etc. Call the Board office for additional information.
- Through the Urban Fellows Program sponsored by Bronx Borough President Diaz, the Board was assigned a graduate student, Marcel Negret, from the Pratt Institute, to visit the waterfront communities in Bronx Community Board #10 and prepare a resiliency study, and address preventive measures and protection strategies that could be taken. He has provided documentation of his efforts to the Board tonight which will also be presented to the elected and Borough President.

### **COMMITTEE REPORTS**

### **EXECUTIVE COMMITTEE:** Mr. Prince

The Committee did not meet in February due to weather.

After a brief explanation by Mr. Prince, a floor resolution was drafted to remove Board Member Joanne Miller due to abandonment of attendance. Reference is made to the Revised By-Laws - Bronx Community Board #10, dated May 2010, Article III-MEMBERS which states "An

appointed member may be removed for cause by the Borough President or by a majority of the appointed members of the Board. Cause shall include three consecutive absences from meetings, or the absence from more than one-half of the meetings in a period of any one year."

A motion to accept the resolution was made by Mr. Talarico, seconded by Mr. Sullivan and unanimously approved by all.

### HOUSING/ZONING COMMITTEE: Mr. Sullivan

The Committee will meet on February 25, 2015. The topic will be the Longstreet Avenue project at which the attorney/owner will present a power point presentation. It will be an informational meeting only, no vote to be taken as the project is not at that stage.

In addition, due to time constraints and the postponement of Committee meetings due to weather, a floor motion is needed on the extension of the side-walk café for George's Restaurant and is presented to the Board for its approval.

"Resolved...at the request of the Chair of the Housing and Zoning Committee of Bronx Community Board #10 that the application continue the enclosed sidewalk café, consisting of 11 tables, 44 chairs, George's restaurant, 3000 Buhre Avenue, Bronx, NY 10461 be presented to the full Board for approval and that this information be forwarded to the New York City Department of Consumer Affairs."

Motion to accept the resolution was made by Mr. Sullivan, seconded by Mr. Bieder and unanimously approved by all.

• Illusions Hookah & Mixology Lounge, 3221-29 Westchester Ave, 10461, between Continental & St Paul Aves, License #NEW.

Both resolutions did not pass separate roll call votes. The results are as follows:

- <u>Casa Restaurant & Lounge</u> fourteen (14) yes, twelve (12) no, four (4) abstentions.
- <u>Illusions Hookah & Mixology Lounge</u> eight (8) yes, fifteen (15) no, seven (7) abstentions.

A discussion among Board members ensued about these two establishments varying from the creation of NYC Council legislation to outlaw hookah bars, which are now legal in the City of New York and the use of vapor as opposed to nicotine. In addition is was added that the 500 ft. rule should be enforced and noted that it is a means in which establishments can be flagged by the State Liquor Authority (SLA) for board/community review and a member stated that most restaurants are exempt from the 500 ft. rule. A recommendation was made that it is up to the SLA to make the final decision.
