DSNY has increased the number of recycling baskets in Manhattan. However, service has not had a corresponding increase. What is the funding in FY17 and projected for FY18 to increase service of recycling baskets? Please update us on the status of this initiative.

DSNY does not have funding to expand this operation. Street recycling experiences misuse and contamination and has led to DSNY pulling them. DSNY has removed 271 out of 892 baskets due to excessive contamination.

The FY 2016 Preliminary Mayor's Management Report reports that the number of violations issued for illegal postering in the first four months of FY 2016 (272) was dramatically less that the number of violations issued during the same period in FY 2015 (7,288). Please explain the reason for this decrease and is it a result of funding or staff changes.

It's a function of DSNY losing a court case. Agency must now send certified notice to illegal posting individuals and give them time to respond. "Donate your car" ones are the hardest (only cell phone number on poster). Political candidates do receive advance warning on illegal posting.

AGENDA ITEM 9 : Dirty Sidewalks

The FY 2016 Preliminary Mayor's Management Report states that the number of violations issued for dirty sidewalks has increased dramatically in recent years. Is this the result of a change in Department policy or did the Department receive an increase in complaints? Have additional funds been allocated to DSNY enforcement resulting in this increase?

DSNY now has more supervisors focused on cleaning issues and sidewalk complaints. Program appears to be working, but this is almost always the biggest complaint citywide.

We have 890 Adopt-a-Basket bins now. Have been getting businesses on board and is effective. It has been an increase of 490 in the past year. Commissioner Garcia has set a goal, and supervisors have been conducting outreach to convince more businesses to participate.

AGENDA ITEM 12 : Street Corner Litter Baskets

What funding is allocated in FY17 and FY18 to replace open-wire street corner baskets with rat proof baskets?

COMMENTS:

No intention to eliminate wire baskets. "Big Belly" is expensive and challenging in management. There are more trucks out to collect before basket overflows. Homeless shelters are on organics collection, too! Proper use of wire baskets should not lead to overflow. Even high-end rat-proof baskets have been seen overflowing and having litter flowing into nooks and crannies. It is not always a good move in Manhattan to conduct repeat collections due to high population. Illegal dumping has been a huge problem. Enforcement crew has been out to ticket violators. DSNY can either add or remove baskets if necessary. Manhattan baskets are already receiving two to three services a day.

All "Big Belly" baskets in Manhattan are BID purchases and BID maintenance. No plan to expand outside BID areas in Manhattan. "Big Belly" requires a lot of work to collect, as well as a master key to open and re-lock. "Big Belly" is partly a compactor, but the obstacle to it has been mainly graffiti. DSNY is working to put a layer of "skin" on the receptacle. It is also more costly, with more parts, to maintain. DSNY receives daily report on full "Big Belly" receptacles, but it is often too late by the time DSNY route arrives at the almost full receptacle.

Like to have support for garage on 23rd Street. There is literally no room for CB 6, and CB 8 is far from the district base and more exposed to snow emergency events. There is never enough basket trucks! We all need wider sidewalks and streets!

All CMs receive significant funding for cleaning. It is on parallel track with DSNY budget. CMs should take into account of their CBs.

ADDITIONAL NOTES:

Gormley: Do we need to notify illegal posting individuals repeatedly?

Garcia: Flyers often different enough! Also, it is hard to track the violators down.

Bodine: Thanks for coordination on 23rd Street and "double parking" issues. Over 62% of NYCHAs are participating live in DSNY initiatives. Is there a list? Do you know the number allocated to CMs?

Garcia: It will still be a problem because we are still finding places to park our vehicles with Hudson Yards growing exponentially. Each CM receives about \$162,000 a year for sanitation initiatives in their districts.

Diller: CB 7 asks for Sunday basket collections year after year. It looks a mess around destinations if there is none.

Garcia: Sunday collection began in April 2016. Lots of Manhattan neighborhoods have Sunday collections, unlike the Outer Boroughs (who lost much of it). It is funded via overtime as Sunday is always double-time pay. Please continue to prioritize Sunday collection to allow it to continue.

Stetzer: Lower East Side schools are not doing recycling properly. Is there any mean to allow schools to do it properly? Is it funding issue? Or is it a custodian issue?

Garcia: DSNY cannot ticket school staff. Funding has been allocated to have staff to carry it out. It is an adult problem! DSNY has subcontract with GrowNYC on the program and also has outreach. DSNY is now having an RFP to put together video program to feed live set-out information to DOE.

Winfield: CB 11 is still having concerns over the garage. Is it going to be a new facility, or only a rehabilitation of the existing one?

Mescain-Archer: DSNY continues to refuse to relocate garage. You are planning after having found a site first. There are two garages within four blocks and no plan to consolidate garages--it is too much for East Harlem to handle.

Garcia: We must find space to fit existing and new operations first.
