- Carters are on notice to make sure they are aware of all customers they should currently be servicing. BIC may issue violations for non-compliance with requirements for servicing customers.
- BIC violations
 - A reminder of the upcoming changes to the BIC violations process as the primary venue for adjudication of violations changes from OATH Trials Division to OATH Hearings Division.
- Customer Register
 - Customer register data for July 1, 2024 through September 30, 2024 must be submitted to the Commission no later than October 31, 2024.
 - All companies must provide complete and reliable data by the deadline.

Agenda items requested by non-BIC TWAB attendees

- Discussion of logistics and progress related to the ongoing implementation of CWZ customers in Queens Central.
- TWAB members requested clarification regarding training requirements for trade waste employees, especially regarding company sales where employees already received training from their previous employer.
- Discussion regarding the role of trade waste brokers as the topic relates to CWZ.
- TWAB members raised two additional concerns: increase in issuance of violations related to spillage, and an increase in cardboard theft.
