#### Josephine Fernandez-Byrne, Committee Chairperson

#### Meeting location and transportation concerns.

- Committee Chair Josephine Fernandez (Chair) and Mr. Josue Melendez (Bronx Government Affairs Officer)-NYC Department for Aging introduce themselves.
- Concerns about meeting location at Dream School, including lack of accessibility and safety. The District Manager mentioned that Chairperson Alayeto offered free transportation.

#### Aging services in New York City, demographics, and program overview.

- Mr. Josue Melendez is the Bronx Inter-Government Affairs Officer for the Department for the Aging.
- Agency provides services and resources for 20% of New York City's older adult population.
- Services include transportation, case management, and the Foster Grandparent Program.

## Services for older adults in NYC, including centers, home-based care, insurance, and employment programs.

- Mr. Josue Melendez discusses older adult services in NYC, including centers, home-based services, and additional supplementary resources.
- Mr. Josue Melendez highlights specific services such as elder justice, health insurance, and senior employment programs.

#### Aging in place and community care for older adults in NYC.

- Mr. Josue Melendez: Community Care Plan aims to keep older adults in their homes.
- Mr. Josue Melendez: Cabinet for Older New Yorkers tackles issues related to older adults.

- The agency occasionally puts out material in the community to promote its services, but there is a lack of knowledge about what they do.

- Member Brenda Goodwin discusses difficulties in accessing social services for an elderly family member.
- Mr. Josue Melendez advocates for more PSAs and outreach to senior centers in NYC.
- Member Brenda Goodwin discusses issues with banks not providing senior-specific services, despite mandate.
- Recommendations include advocacy, legislation, and improving accessibility in community.

#### Senior services, transportation, and technology access.

- Member Brenda Goodwin & Committee Chair Josephine Fernandez-Byrne discusses challenges faced by seniors in NYC, including transportation and access to technology.
- Speaker mentions specific programs and services available to seniors, such as free phones and high-speed internet.
- Members emphasizes the importance of advocacy and connecting seniors with resources and support.

#### Financial challenges faced by seniors in the community.

#### Educating seniors about fraud prevention and financial protection.

- Public Member Elena expresses concern about quick turnaround time for event, need for transportation.

#### Planning activities for seniors at various centers.

- Committee Chair Josephine Fernandez-Byrne discussed coordinating activities for seniors at various centers with the youth committee.
- Committee Chair Josephine Fernandez-Byrne spoke to Dara Espinosa at East Side settlement, who was agreeable to planning activities with the youth committee.

#### Collaborative event planning between seniors and youth committees.

- The senior and youth committees will collaborate for the first time to plan a date for their centers.
- The seniors and youth will meet separately before coming together for the next step.

#### Nominations, calendar year suggestions, and meeting adjournment.

- Committee Chair Josephine Fernandez-Byrne nominates Ms. Elena for the position of Committee Vice Chair
- Committee Chair Josephine Fernandez-Byrne seeks suggestions for next calendar year's projects, including TD Bank presentation.

Follow up on transportation services provided to Rincon Center seniors.

Research past transportation for Rincon Center seniors.
