Chairman Joseph Russo began the hearing at 7:00 p.m. with the Pledge of Allegiance. He transferred over the meeting to District Manager Cruz for the District Needs Statement FY 2016.

Public Hearing: District Needs Statement FY 2026

District Manager explained the annual District Needs Statement process and encouraged all to submit items to be included which will be submitted to the NYC Department of City Planning at the end of October. There were no submissions to discuss nor public comment. The Resolution below was voted on and the next item on the Public Hearing Agenda began.

Resolution (1)

"Resolved...at the recommendation of Bronx Community Board #10 that the District Needs Statement for FY 2026 be voted on and forwarded to the NYC Department of City Planning."

A motion to accept the Resolution was made by Mr. Popovic, seconded by Mr. Accomando and unanimously approved by all. **The Resolution passed.**

Public Hearing: BSA Lobster Box (BSA Cal. No. 2024-36-BZ)

District Manager Cruz discussed the request. The restaurant formerly Lobster Box, 26 City Island Avenue, is filing a City of New York Board of Standards and Appeals (NYCBSA) "use exception." A portion of the parking lot extends into the residential district. The use extension lapsed in 1975. It is because a portion of the

parking lot is within a resident zoning district that it is needed. This will help to extend the parking lot to up to 20 spaces. The establishment appeared at the June 2024 Housing and Zoning Committee meeting. A very brief discussion among Board members on the application took place followed by a vote.

Resolution #2

"Resolved...at the recommendation of the Housing and Zoning Committee of Bronx Community Board #10 that BSA Cal. No. 2024-36-BZ, Lobster Box Restaurant be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Accomando, seconded by Mr. Smith and unanimously approved by all. **The Resolution passed.**

A motion to close public hearings and continue with the public meeting was unanimous.

PUBLIC PARTICIPATION SECTION:

- 1. NYPL Baychester (Leslie Brown) and Throgs Neck (Leida Velasquez) Branches: All library activities have resume and are active. Libraries will be holding a banned book event; at the Throgs Neck site a reading program with a therapy dog will take place. Flyers with calendars and events were left for the community.
- 2. Leon Tulton, Riverbay resident: Palmer Avenue express bus station needs a shelter; Baychester Avenue median wants an installation of a barricade alongside the median to prevent motorists from driving over it.
- 3. Peter Del-Debbio: American Legion on City Island will have a Veterans Day Ceremony on Nov. 11 at 10:30 a.m. followed by refreshments. Mr. Del-Debbio is a member of the NYC CERT Team 10 on Donizetti Place; the team is in need of recruiting additional members. Members must receive training. He added that the CERT teams assist with local mishaps at the direction of emergency services. Members are not put in the line of danger. A discussion with questions and members asked questions about the training, locations in the Bronx. Location is provided only in Brooklyn.
