II. Outdoor Dining Application 20240803020016 – HK Kitchen and Drafthouse

The Committee reviewed the application and met with the applicant. The diagram on the application shows a total of six tables/twelve chairs. The committee voted unanimously in favor of the application.

III. Street Co-Naming Requests

The families of Betty Murphy and Skip Giacco attended the meeting and spoke of the reasons for requesting street co-naming requests. The Committee voted unanimously in favor of both.

Betty Murphy – corner of Clarence and Randal Avenues Skip Giacco – corner of Fordham Street and City Island Avenues

"Resolved...at the recommendation of the Municipal Services Committee that the street conaming requests for Betty Murphy at the corner of Clarence and Randal Avenues, and Skip Giacco at the corner of Fordham Street and City Island Avenues be forwarded to the full Board for approval and the Office of Council Member Marmorato."

IV. Jose Saldana, Assistant Supervisor, Bureau of Community Affairs spoke about DSNY changes to trash related issues. He took questions from the committee and public.

Composting is now mandatory and began this week. Compost must be in a securely covered receptacle. It doesn't have to be an official NYC receptacle.

Until November 12, household trash can be placed out in bags. Effective November 12 household trash must be in a securely covered receptacle.

In June, 2026 all household trash must be in an official NYC receptacle. To purchase official NYC receptacles: call 1-855-NYC-BINS or 1-855-692-2467. Mr. Saldana noted that store bought bins are more expensive that the NYC BINS.

Call 311 for stolen bins. Summons will be given for garbage receptacles without lids. Business owners must keep the front of their stores clean and eighteen inches into the street; most have private sanitation services will take trash and compost.

New Business: Kevin Daloia is requesting universal daylighting and suggested that Emily Shingay present this to the Board. This will be followed up with the District Manager Cruz.

Old Business – none

Meeting adjourned by a unanimous vote.
