

Economic Development Committee Meeting rev. February 5, 2025

The meeting began at 7:00 PM with the Pledge of Allegiance. All attendees are welcome at this time. Mr. Accomando informed the committee that they had a long agenda for tonight meeting. But also noted that the PO Reports were very good and that the meeting should go fairly quickly. There were 11 Renewals and one New License. At this time the establishments were advised that when called upon to state your name, position and give a small synopsis of what's been taking place at their establishment. Mr. Accomando stated that he will first address each establishment and then turn it over to the committee for their questions and comments or any concerns they may have. At this time each establishment was called upon separately and was well received by the committee. Some noise complaints were addressed by the committee and some of the establishments that was quickly resolved. They were two establishments that were not present at the time of the meeting. Mr. Accomando noted that their PO. Reports were in line and that he will follow up with them. Because of so many establishments in attendance Mr. Accomando stated that if there was anything on the PO. Report that was disturbing his Committee wouldn't have approved their Renewal on the establishments not present. This was to send a clear message that attendance is required for their Renewals. At this time Mr. Accomando called for a motion to accept the Renewals. It was made by Mr. Popovic and seconded by Mr. Hooks and voted on unanimously.

Old Business: Mr. Accomando addressed the Committee about the two restaurants that were cited for under-age drinking. Barrio Bx that was cited is now closed and the other was Lavie Mex. I spoke to Sergeant Major and he said he spoke to the owner and that she was very cooperative, and he was very satisfied with the action that she took and that a whole staff was retrained. I also called and spoke to the owner as well she stated she went to court and received a 60 day suspension. Since then, they were revisited and passed.

New Business: Mr. Bob Bieder addressed the committee and stated that the 45th Precinct is still down 30 officers and urged us to reach out to our public officials to express concerns. It may be helpful in securing additional offices for the 45th Precinct.

A motion to close the meeting was made by Mr. Smith and seconded by Mr. Popovic. The meeting ended at 7:53 PM.

HEALTH and HUMAN SERVICES FEBRUARY 5, 2025, 7:00pm

The guest speaker was Lt. DiPierro from the FDNY Safety Education unit regarding fire safety and prevention. They stated everyone should have a fire alarm on each floor, a carbon dioxide alarm, and a fire extinguisher in their home. The fire extinguisher should be hung up and easily accessible. They warned against the dangers of overloading power strips. Furthermore, they advised that if you find yourself relying on power strips too much, you should consult a professional on a better solution. They also went over what to do in case of a fire and in different situations. The speaker stated that if a fire is above you, you are safe and should evacuate calmly since fire rises. However, if the fire is below you, there is more cause for worry. If you do find yourself above a fire, do not open the windows. Opening the windows allows smoke to enter your residence and puts you at risk of suffering from smoke inhalation. Also, when using the fire escape to evacuate the building, the speaker stated that it is much faster and safer to go down backwards. The speaker also informed us that we should find out whether we live in a fireproof or non-fireproof building. He informed us that we can find out at FDNYSmart.org or to call 311 if your building is not on the list. Finally, the speaker informed us that we should inform our local firehouse about any person with mobility in the residence.
