Land Use Committee June 10, 2024

Bobby Link - Vice Chair call to Order at 703pm. Introduces Akerman Law Firm to present first issue for affordable housing project on NW 222nd Street. Richard Bass - Urban Planner and Leah Vallone - summer intern from the Akerman Firm attended.

Richard states the owner of the site has held title for ten years. Background in the Bronx. Richard further states he met with the council member and Borough 'President who expressed initial support. Adds caveat that this is very early outreach. Current zoning is R6A and R6. They are proposing an R8A and continuing the commercial overlay. 178 square foot development. 100% affordable. By the time through ULURP and constructions, 4 or 5 years from now. Site is between two subway stops and at the junction bus lines.

Two different ideas for construction, one is to increase the height next to the elevated train.

Luke states that 100% affordable is great to hear but questions which program would guarantee the affordable units. Richard responds there are programs today, but not guaranteed when construction is ready to move forward. He adds the client is committed to affordability.

Questions about parking concerns. Richard responds there is dialogue with the Borough President but due to costs of 60-100K per parking space, parking is unlikely.

Karl asks about parking and conversations with the MTA. Richard responds that he will talk to the transit authority but has not yet. He adds that 100% affordable means HPD will be involved.

Beatriz ask about studies regarding the impact the project will have on infrastructure. Richard responds that there are 19 chapter requirements to look at electricity, stormwater, etc.

Beatriz asks additional question about what happens if people can't afford and building remains empty. Richard unequivocally states this isn't going to be a shelter. He adds that affordable housing projects are not normally vacant.

Beatriz also asks whether there is any opportunity for a school. Richard says school construction authority passed on the site.

Arielle raised concern about a different site in the Bronx that was not finished. Richard responds that the site will be 100% affordable. He vouches for his client who he represented in eminent domain cases when the city condemned gas stations near Barclays.

George says prolific builders have built housing through NYC connect claiming the units will be affordable and then turned around and took it off the market and we are getting a homeless shelter. Brenna responds that this is a step in the right direction, loaded question.

George and Arielle follow up about the shelters and lack of responsiveness to the questions. George further discusses warehousing.

Brenna responds that this is a multiple faceted issue. In terms of the warehousing, focus is generating new types of housing. Certain ways that we are limited in terms of monitoring characteristics of this. Limits to what people can build since not updating since 1961.

Discussion ensues about housing vacancy, warehousing, building renovations, and public housing. Laura states UAP will be affordable housing like any other affordable housing unit.

Robert Hall discusses HPD vouchers. He says NYCHA is housing choice voucher which does not get right to come out into HPD land. HPD voucher you can move around.

Luke states that City of Yes is a great proposal. A little bit of housing everywhere, there are issues coming up but zoning is not going to fix it. We need more HPD funding and homeless services. If you talk to anyone who is renting it's crazy out there. It's time to give other people their chance to find an affordable place to live.

Bobby says he is voting against because of concerns of shelters, ADUs, and transit housing for five story buildings in single family districts.

Karl raises whether the infrastructure can support the planned growth. He says the combined sewage overflow into the rivers is significant and adds that we are on the verge of brown outs.

Alfredo discusses the parking situation. He says he has five cars and doesn't take the train. People have cars, like cars and need cars.

George discusses timelines and presentation of the proposal on the verge of the dismissal for the summer. He argues that if you are a new homeowner before City of Yes, now your neighbor will be flipping the property. He points out that no parking requirements. He says the community board should have had more time to go through methodically.

Beatriz states that we need a City Planner to look at the expert testimony to analyze these issues.

Arielle says no plan to figure out what doing with flooding and not have a bigger problem later. Point missed is that Landlords are already doing this and not clearing up
