Capital Budget Priorities & Requests	 Priority 1 to be kept. Priority 2 to be kept but amended to propose programs to help with accessibility. Priority 3 to be kept but amended to include a basketball court and indoor pool. Priority 4 to be kept but to update the number of shelters in the explanation to 84 from 26. Priority 5 through 16 to be kept and without any changes. Priority 17 to be kept even though it is about to begin in 5-7 months. The Board agreed to keep this one on the budget until it is completed or at least until construction begins. Priority 18 through 29 to be kept without any changes. Priority 30 to be amended to focus primarily on Highbridge because Grand Concourse is already funded. Priority 31 to be kept but as an update on priority 31, work is slowly happening. Priority 32 and 33 to be removed because they are completed. Priority 34 to be kept.
Expense Budget Priorities and Requests	 Priority 1 through 4 to be kept. Priority 5 to be kept but to remove language around the "pandemic" and include everyone/make open/apply to everyone (pre/post-pandemic). Priority 6 through 8 to be kept. Priority 9 to remain but amended to include supportive services for mental health, support for senior citizens' mental and physical health. Update to follow up separately. Language in priority's explanation to be updated to 35,000 from 14,000 children living in shelters. Priority 10 to be removed.

- Priority 11 to be kept.
- Priority 12 to be removed and added to Priority 7 in the Capital Budget Priorities & Requests. Language in Priority 12's explanation to include to sell their wares.
- Priority 13 through 21 to be kept without any changes
- Priority 22 to be kept and amended to include a medical provider, text to follow.
- Priority 23 through 27 to be kept without any changes.
- Priority 28 to be kept but be amended to remove PODS.
- Priority 29 is missing.
- Priority 30 through 36 to be kept without any changes.
- Priority 37 to be kept but amended to include the Fortune Society as one of the example organizations, alongside CASES and CJA.
- Priority 38 through 40 to be kept without any changes.
- Priority 41 to be amended and re-submitted with new wording at a later date.
- Priority 42 to be kept but amended to move to HRA as the Responsible Agency.
- Priority 43 to be kept for additional funding than what is already approved for this priority.

Public Session:

- 1. Kenneth Agosto, representing Bronx Borough President Office, Vanessa L. Gibson
 - Had to present during the public session due to a conflicting meeting at Bronx Community Board 7.

Report by NYPD 44th Precinct: Captain Ortiz-NYPD 44th Precinct provided a report from September 23, 2024 to October 20, 2024 where there was a 10% increase in major crimes. Robberies, burglary, grand larceny were up but the number of automotive-related crimes is down.
