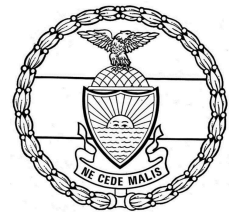

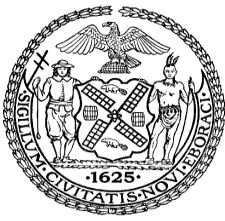

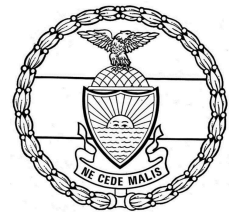

Total Task Force

1,675 total compliance and intelligence inspections have been conducted.

\$58,295,978 in Civil Penalties have been issued and \$28,197,665 of illicit products have been seized.

2023 Year to Date

1,472 compliance and intelligence inspections have been conducted.; 211 arrests, 371 C-Summons issued, 314 Sheriff NOVs, 2,055 DCWP NOVs, 8,111 DCWP Violations, 45,755 DCWP Counts.

\$51,218,278 in Civil Penalties have been issued and \$21,326,685 of illicit products have been seized.

January 2024

125 compliance and intelligence inspections were conducted which resulted in 20 arrests, 39 C-summons, 3 Sheriff NOVs, 192 DCWP NOVs, 859 DCWP Violations, and 4,218 DCWP Counts.

\$4,935,200 in Assessed Civil Penalties and \$1,698,496 of illicit products have been seized.
