pedestrian islands for those waiting for and boarding the buses. Also, improving ADA compliance and passenger safety.

- 4. A question about island width will not impact the passage and roadway width of larger vehicles.
- 5. Comments about vehicles in the pictures not legally parked need to be corrected. Also, will drivers be courteous for busses loading and unloading, any enforcement. There needs to be areas labeled with appropriate signage.
- 6. There was a request for NYPD Traffic Enforcement to come to one of our meetings to address our concerns.
- 7. Questions were asked about the following:
 - a) Who will be responsible for cleaning and maintaining these areas? Enforcement was once again addressed.
 - b) Will the bus stop at 195th be addressed since students use that crossing?
 - c) Finally, can there be a review by the MTA on the Westchester Bus Service lines usage stops? It was mentioned buses should be free.
