I. Call to order

II. Service Requests

DOT

- Update on Screven, Howe & Barrette One-Way Installation. –As per Emily-DOT, the study is still being conducted. There are no follow-up actions needed on behalf of CB9.
- Update on removal of Overnight No Standing on Zerega between Bruckner and Seward. –As per Emily-DOT, there are 3 more signs left which are already scheduled to be removed.

Parks

- How long does a person need to be deceased before becoming eligible for Parks renaming/co-naming? Is Parks renaming/co-naming permanent?
–Print out of most recent criteria was shared by Valerie-Parks. She encouraged residents to opt for adopting a Parks bench or planting a tree rather than Parks renaming which is extremely difficult to acquire. Parks renaming are done mainly for individuals who are really regarded in the community.

NYPD

- 430 Leland Ave-follow-up on collarless biting dog. –No representative from NYPD was present at meeting.

DDC

- Various complaints from residents regarding no notices before work is conducted (Permit #: X012019294C84, 1230-1244 Metcalf Avenue, working on Fteley Avenue). –No DDC representative assigned to this project was present.
- Status of foul odor resolution/odor control, Pugsley Creek Project. –Two odor controls & tarp has been installed. Contractors will be back onsite next week for parking. Shock treatment has been conducted to strengthen and close up sewer. Project is still on track to be completed by the end of Dec. which is a year ahead of schedule.

- Community Appreciation Dinner was a success, all are encouraged to attend next year.
- Renovation of new office space is still underway.
- College Aid Sanzida is no longer with CB9 and replacement for her position is underway.

IV. Agency & Elected Official Office Reports

- Josue-DFTA announced several new Elder Abuse initiatives and representative will attend Seniors Connected this month with more information.
- Christina- DA CAU announced Another Chance Event on Oct 26th had 390-400 people in attendance. 234 individuals met with staff and had their records run, 60 cases were dismissed and these individuals left with dispositions, over 84 individuals were assisted with employment issues and had screening completed for expungement, 105 sealing screenings were completed as well. Screenings for expungement can be completed any day at DA's office, not just on event dates, 12 applications were fully completed.
DA also hosts Mock Trial Program beginning December 10th. Orientation begins on December 4th for high school students in any borough. Participants in this program are coached by ADAs. 2 outstanding students receive an internship at the office.
- Erica-DOH announced Flu vaccines for the flu season at participating pharmacies. Residents can call 311 to help identify which locations are participating.
