



## **District Service Cabinet Summary February 16, 2021 - 1:00 PM**

**Description:** *The City Charter establishes a District Service Cabinet (DSC) in each community district, to be composed of agency officials responsible for local service delivery. The District Manager of the Community Board chairs the District Service Cabinet, whose members include representatives of the agencies that deliver local services to the Community District. The District Service Cabinet is the primary mechanism through which local service delivery issues can be raised, discussed and resolved. If used effectively, the Cabinet can provide the basis for a comprehensive approach to service delivery within the community district.*

### **I. Service Requests**

#### **1. Parks**

a. Cleaning of Parks Property adjacent to 214 Harding Park – Chris Acosta, Parks Dept has spoken to resident who made this complaint to confirm that Parks will be maintain this area now that it is fenced.

b. Conditions at Noble Playground (Schedule meeting with Parks & Sgt Ortiz) – NYPD will be operating Parks unit to enforce appropriate permit use (among other things) in areas such as Noble Playground, Parks and NYPD will be in touch if any permits need to be redacted.

#### **2. DCA**

a. Car wash located in front of 1240/1242/1244 Colgate Avenue

b. Car wash located in front of 2267 Westchester Avenue

c. Car wash located at the corner of Story Ave and Morrison Ave/Boynton Ave

DCP will be conducting inspections at these locations.
