



District Service Cabinet Summary

January 18, 2022 - 1:00 PM

Description: The City Charter establishes a District Service Cabinet (DSC) in each community district, to be composed of agency officials responsible for local service delivery. The District Manager of the Community Board chairs the District Service Cabinet, whose members include representatives of the agencies that deliver local services to the Community District. The District Service Cabinet is the primary mechanism through which local service delivery issues can be raised, discussed and resolved. If used effectively, the Cabinet can provide the basis for a comprehensive approach to service delivery within the community district.

II. Agency Reports / Announcements

- A. DFTA, Josue- Seniors can get tablets through their senior center.
- B. CCHR, Orlando- Human rights law expansion on employment assessments. On March 12 to include most domestic workers in the city. If someone is getting hired to do work, these people are now covered under law and can't be discriminated. Anyone hiring are also liable under the law. A lot of outreach will be done.
- C. Inspector Ramsey- The Police Department has a new commissioner. Inspector Ramsey stated that there has been a huge shoplifting/car theft problem and he wants to have a loss prevention meeting with providers.
- D. Castle Hill library NYPL has paused in all in person programming. The Castle Hill branch will have pediatric vaccination beginning the 29th.
- E. DCWP- Free tax prep for families. NYC paid sick leave, workers who have COVID 19 can get time off regardless of immigration status. There is a special leave for COVID vaccine. NYC regulating online food delivery service. Delivery apps must pay delivery workers new minimum wage rate.

- G. Valerie Davis, Parks- Lifeguard training for summer has started. People who participate or tryout must be vaccinated.
