

District Service Cabinet Summary

April 19, 2022 - 1:00 PM

Description: The City Charter establishes a District Service Cabinet (DSC) in each community district, to be composed of agency officials responsible for local service delivery. The District Manager of the Community Board chairs the District Service Cabinet, whose members include representatives of the agencies that deliver local services to the Community District. The District Service Cabinet is the primary mechanism through which local service delivery issues can be raised, discussed and resolved. If used effectively, the Cabinet can provide the basis for a comprehensive approach to service delivery within the community district.

I. Service Requests

- **1. DOT-** DM to follow-up with Mr. Soto from DOT on service requests below.
- A. No Standing Bus Lane Installation on WPR- DM Rivera stated that bus lanes were already painted, just waiting on signs.
- B. Request for additional safety markings and/or devices at Virginia Park- White Plains Road and Cross Bronx Expressway
- C. Update on the study for a capital infrastructure project to reconstruct WPR and Stickball Blvd.- DM Rivera asked if survey is still in the works.
- D. Unionport Road, Starling Ave to Westchester Ave Safety Improvements

2. DOE/Parks/DOT

A. Request for: increased lighting, new or additional cameras, increased teacher parking at PS 100X - 800 Taylor- DM Rivera stated that a meeting/call will be setup for this issue since it's multi agencies, so everyone can be on the same page.
