



District Service Cabinet Summary

May 17, 2022 - 1:00 PM

Description: The City Charter establishes a District Service Cabinet (DSC) in each community district, to be composed of agency officials responsible for local service delivery. The District Manager of the Community Board chairs the District Service Cabinet, whose members include representatives of the agencies that deliver local services to the Community District. The District Service Cabinet is the primary mechanism through which local service delivery issues can be raised, discussed and resolved. If used effectively, the Cabinet can provide the basis for a comprehensive approach to service delivery within the community district.

Service Requests

A. Abandoned property at 216 Husson Avenue causing hazardous conditions for neighbors. Resolution: "An inspection was conducted on 04/06/2022 and a Request for Corrective Action was placed on the property."

2. FDND

A. Open Hydrant in front of 1015 Boynton Ave. Resolution: FDNY was notified and will take action.

3. DOE

A. Litter on Morrison and Stratford on the side of JHS 123. Resolution: As per Principal Hallenbeck, "I will talk to the custodian and let him know about the complaints."

4. NYCHA

A. Leaking pipe inside apt at 2125 Randall Ave. Resolution: As per NYCHA, "Our office will escalate this issue to management."

B. Resident Section 8 inquiry. Resolution: NYCHA Section 8 provided extensive update on status of subsidy.

5. NYPD

A. Noble Ball Field Enforcement. Resolution: As per NYPD, NCOs, Conditions, and Patrol will frequent the playground and enforce any violations.

6. DOT

A. Sidewalk condition near water drainage on Story Ave and White Plains Road.
Resolution: DEP will look into this matter

7. DOHMH

A. Rat Infestation at 1966 Newbold Avenue. Resolution: DOHM will contact the Pest Control Team regarding this complaint.
