### I. Introduction

**A. Committee Description:** The public safety & transportation committee represents the community's interests with regards to sanitation, crime, fire-ems, quality of life, NYS liquor license application recommendations, street activity permit applications, street re-naming application, transportation and acts as a liaison between community members and the New York Police Department & Fire Departments, NYC Department of Environmental Protection, NYC Department of Sanitation, NYC Department of Transportation, NYC Department of Sanitation & NYS Liquor Authority.

### 1. Speakers

**A.** DDC Soundview Sewer Project/Maravillas Roadway

Reconstruction of Diversion & Regulator Chambers

Construction Start: May 2022, Project Completion: Fall 2025 (3 Year Completion Time Frame), Project Total Budget: \$52 Million

Project location: Intersection of O'Brien Avenue from Soundview Avenue to White Plains Road and O'Brien Avenue from Soundview Avenue to Leland Avenue and all intersections in between. The Chambers were discovered to be in very Poor-Condition during the previous CS-ER-WCP Pugsley Creek Capital Construction Project. This is a coordinated multi-agency effort by the City of New York (DEP, DOT, and DDC). As per DM Rivera, we expect great communication as DDC Contact Yolanda Velasquez was the same contact for the previous project and was great at staying in touch. Maravillas Restaurant was accommodated with no significant impact.

**B.** DOT E-Scooter Pilot Phase II (2 Year Pilot)

E-Scooters are defined as a device with handlebars, a floorboard or seat, and an electric motor that have a max speed of 15 mph, are not registered with the DMV, and follow the same rules & regulations as bicycles. The E-scooter share Program is a network of shared e-scooters where users find, unlock, and lock e-scooters through smartphone apps, intended for point-to-point transportation, and are an additional transportation option with dockless, free-locking vehicles.

This lot will be divided in half for both parking and for the establishment with 125 seating. Hours of operation begin at 11am for lunch and weekday closings at 1am and weekend closings at 2am. Security is a possibility if needed. Security cameras will be surrounding the establishment and available to NYPD as necessary. Hiring will be conducted locally. DM Rivera will be conducting a site visit with NYPD and Community Affairs. Liquor License stipulation of not serving liquor past 1am on the weekdays or 2am on the weekends will be mandated for the first term of the license and removed if no issues arise.
