New York State Education Department (NYSED), ACCES-VR is tasked with assisting individuals with disabilities to obtain and maintain employment. In addition to providing services to participants, this org. also provide no-cost Business Services to employers, community based organizations, training programs and any other entities that may be interested. In addition, no-cost, customizable workshops (ADA and Disability Etiquette) can be provided to staff and the community. Other programs include WTO and OJT programs where employers can be reimbursed a candidate's first three months of salary for hiring Bronx ACCES-VR talent.

### A. Emergency Housing Summit

DM Rivera and ADM Alonzo had a virtual meeting with Congress Member AOC's Office and discussed the possibility of her office hosting a Housing Town Hall in the coming months.

- Topics for Discussion could include: High Cost of Living, Increasing SNAP, Increasing funding/stipends for individuals meeting poverty standards, Emergency Section 8 (HPD and NYCHA), Bill to protect low-income residents from market value rent, NYCHA excessively long waitlist, Housing Connect ADA Compliance, Housing Court eviction prevention for rent increases due to market rate, Lack of Adequate Healthcare (this may be a topic for a different forum), Maintaining Financial Poverty Program.
- Potential agencies to contact to engage in these conversations include: Congress
  Member AOC to discuss high cost of living, DHS and HRA to discuss increase in SNAP
  benefits and stipends/vouchers for individuals meeting poverty standards, HPD to
  discuss Section 8 and Housing Connect NYCHA to discuss Section 8 and long waitlists,
  Housing Court to discuss eviction prevention for rent increases due to market rate, Local
  Elected Officials to discuss bill to protect low-income residents from market value rent,
  Mayor's Affordable Housing Leadership Team (potential invite to discuss most of the
  matters listed)
