



District Service Cabinet Summary

April 16, 2024 - 1:00 PM

Description: The City Charter establishes a District Service Cabinet (DSC) in each community district, to be composed of agency officials responsible for local service delivery. The District Manager of the Community Board chairs the District Service Cabinet, whose members include representatives of the agencies that deliver local services to the Community District. The District Service Cabinet is the primary mechanism through which local service delivery issues can be raised, discussed and resolved. If used effectively, the Cabinet can provide the basis for a comprehensive approach to service delivery within the community district.

I. Service Requests

1. DSNY

A. Westchester Ave Walk Through Update

DM Rivera will be looking into get an inter-agency efforts to tackle Westchester Ave.

As per Sgt Soriano, DSNY is needed in order to help confiscate equipment on Westchester Ave from offending vendors.

2. NYC Schools

A. Substitute Teacher Recommendation Process

Alina Dowe from Mayor's CAU can connect CB9 to citywide NYC Schools Rep.

2. DYCD

A. BRAG Program at 43rd Pct

DYCD inquired if the 43rd Pct has requested this program via PD chain of command.
