



District Service Cabinet Summary

November 14, 2023 - 1:00 PM

Description: *The City Charter establishes a District Service Cabinet (DSC) in each community district, to be composed of agency officials responsible for local service delivery. The District Manager of the Community Board chairs the District Service Cabinet, whose members include representatives of the agencies that deliver local services to the Community District. The District Service Cabinet is the primary mechanism through which local service delivery issues can be raised, discussed and resolved. If used effectively, the Cabinet can provide the basis for a comprehensive approach to service delivery within the community district.*

I. Service Requests

1. MTA- Follow-up

A. Update on feasibility of bus turn before Clason Pt Park (Potential Swing Gate Closure)

2. NYPD Transit/ Mayor's CAU

A. Is Mayor's CAU still the contact for Commercial Truck Overnight Parking in the District- Alina the mayor is aware of this situation and is working on a solution.

II. Old Business

1. HPD

A. Resident concern with 311 not taking HPD related complaint over the phone. Resolution: As per HPD, "Probably the reason 311 will not take the complaint is that it seems complicated. Please ask your constituent to call 311 with a short complaint about the reason he needs an HPD Inspection."

2. Parks

A. Graffiti on Noble Playground. Resolution: As per Parks, District Supervisor will inspect and remove graffiti.

B. Noble Playground Complaints: Park sign to be posted: Park hours: Monday to Sunday: 7am to 7pm; Request for Park to be opened and locked on time as it's rarely closed at night; pics show park after 10pm; Park sign: No Dogs in Playground area, Basketball Court and Ball field; Dogs allowed on exterior of park; Park Signs posted to pick up after your dog; Free bags for dog poop on gate; Treatment for rats infestation; Request for Bee Hive in basketball court to be removed. Resolution: As per Parks, "We will advise our night security staff on request for consistent closure times. Also cced is Parks Enforcement for their awareness of loitering conditions. Cced is the Nursery for treatment/removal of hornets' nest and rodent infestation. We will work on placing signage for No Dogs allowed in playground/ballfield/courts."

3. DSNY

A. Illegal Street Vendors at Westchester and Castle Hill and Westchester and White Plains Rd. Resolution: As per DSNY Superintendent, "We have an illegal vending unit that I will forward the below locations to."

B. Illegal dumping on the 172nd St pedestrian overpass between Harrod and Metcalf. Resolution: As per DSNY Superintendent, “E172nd St from Metcalf Ave to Harrod Ave was cleaned 10/25/23.”

C. Trash accumulation at St. Lawrence Avenue between East 174 and 172 Street. Resolution: As per DSNY Superintendent, “I will have an officer investigate the location and take action to correct if deemed necessary.”

4. NYPD

A. Cars parked on the sidewalk in front of 264/266 White Plains Road and O’Brien. Resolution: NCO Officers Pelinkovic and Ludwing were notified for follow-up action.

5. Mayors CAU

A. Commercial Truck Overnight Parking in front of 553 Soundview Ave. Resolution: Alina Dowe, Mayor’s CAU was contacted regarding this matter.
