Public Session

- 1. Ms. Josephine Crisastomo, from the Mayor's Office, was the first guest speaker. She discussed ThriveNYC, a mental health intiative started by the First Lady of NYC, Chirlane McCray. ThriveNYC is a plan of action to guide the city toward a more effective and holistic system that outlines 54 initiatives, 23 of them new, to support the mental well-being of New Yorkers. Additionally, ThriveNYC creates a model that can be applied nationally and a framework for advocacy. ThriveNYC is a bold response to a challenging reality: one in five adult New Yorkers face a mental health disorder each year. Eight percent of high school students in New York City report attempting suicide, and more than one in four report feeling persistently sad or hopeless. Deaths because of unintentional drug overdose now outnumber both homicide and motor vehicle fatalities.
- **2. Mr. Mohammed M. Mujumder,** a Board Member, was the second guest speaker. He announced the Mujumder Family Foundation. The foundation does three things for those seeking help: they are Education, Housing Assistance, and helping Crime Victims.
- **3. Mr. Rogier F. van Vlissingen,** Public Member, was the third guest speaker. He announced that early October, there was an event called the "Community Supper" at Saint Helenas Church. He said it was a success and the goal was to teach individuals how to cook with whole foods. The next event will be on November 18th.
- **4. Dr. Reverend Sidney Hargrave,** a Community Activist, was the fourth guest speaker. Reverend Hargrave announced that he has been making frequent trips to Washington D.C. to protest the Affordable Care Act from being shut down by the current administration. He announced that President Trump signed an Executive Order that cuts 5.8 Trillion dollars from Medicaid and Medicare.

5. Mr. Michael Beltzer, a public member, was the fifth guest speaker. Mr. Beltzer reminded everyone that the 2nd Annual Spooktacular at the Soundview Amphitheater will be held on October 28th.

Elected Officials Report

- **1. Mr. Jason Cintron,** from Councilmember Annabel's Office, was the first representative speaker. He announced that the Councilmember's office is still providing legal consultation services. He also announced that the office provides additional services and clinics as well. He added that the Councilmember and office staff are working alongside Assemblyman Crespo and his staff to do cleanups on all the Bruckner Blvd Overpasses.
- **2. Mr. Devon Harris & Ms. Arnelis Ramirez,** from Assemblyman Marcos Crespo's Office, were the second representative speakers. He announced that the Assemblyman's office is having a meeting with Sanitation and P.S. 123 to clean up the overpass by Stratford Avenue. He added that the staff is following up with DOT in regards to two traffic lights to be installed at Colgate and Westchester Avenues and then on Wheeler and Watson Avenues.
- **3. Mr. Joshua Cortez,** from the Mayor's Office, was the third representative speaker. He announced that the Mayor opened a workcenter for individuals who come from Puerto Rico in response to Hurricane Maria. He announced that the Mayor signed the "Office of Nightlight" bill.
- **4. Mr. Andy Toledo,** from the Borough President's Office, was the first representative speaker. He announced that on Sunday, the Tour de Bronx Biking event will be active.
- **5. Ms. Leticia Teasley**, from Assemblyman Luis Sepulveda's office, was the fifth representative speaker. Ms. Teasley announced that the Assemblyman's office is accepting donations to aid in Puerto Rico in the relief efforts. All donations will be accepted at the Assemblyman's office.
- **6. Ms. Beatriz Pradon,** from the New York Public Advocate's Office, was the sixth representative speaker. Ms. Letitia James is asking the City of New York to provide such as government benefits, English/Spanish employees to help those coming from Puerto Rico, School education where the schools designate English and Spanish speaking individuals to help students from Puerto Rico here in the city.
