A. Jacqueline Carter, MTA Bronx Bus Network Redesign Final Plan

Summary: *Over the past year, we gathered all available bus service data and analyzed demographics for the Bronx, to publish our Existing Conditions Report and develop the Draft Plan. We engaged extensively with elected officials, community boards, and communities through the borough. With this analysis and your feedback, we've developed the Final Plan to redesign the Bronx Bus Network. The redesigned network establishes a strong foundation on which we can continue to build a successful high-frequency network that serves the largest number of riders at the times when they need service the most. This plan also demonstrates our new approach to providing bus service—one that dynamically responds and adapts to the needs and travel patterns of customers and reallocates available resources where they will have the greatest impact. Therefore, our work on the Bronx Bus Network will not end with the release of this report or the implementation of the proposed changes, but will continue as we refine service based on ridership and performance, and respond to feedback we receive from customers.*
