PUBLIC HEARING

ROLL CALL

Chairperson Ms. Fuller requested District Manager Mr. Esposito to call the roll. He conducted the roll call and informed the Chairperson that there were 26 members present, a sufficient number for a quorum to conduct the public hearing.

APPROVAL OF THE AGENDA

Mr. Bruzaitis made a motion to approve the agenda as written. The motion was seconded by Ms. Teague. The motion was unanimously carried.

DCA - <u>UNENCLOSED SIDEWALK CAFÉ APPLICATION</u>: Woodfire Collision (#2018403-DCA) 33 Tables; 68 Chairs (RENEWAL)

A presentation was made for the renewal application by Mr. Robert Calanhan, from Mr. Michael Kelly's Office, representative for establishment. Copies of the written questionnaire were distributed. There are no changes proposed. No comments were received at this time.

DCA - UNENCLOSED SIDEWALK CAFÉ APPLICATION: Ten Eleven Holdings LLC, dba Pencil Factory, 142 Franklin Street (#1133916-DCA) 17 Tables; 34 Chairs (RENEWAL)

Mr. Adam, the manager at the Pencil Factory, presented on the renewal application. They have had the unenclosed sidewalk café for 16 years. There are no changes. No comments were received at this time.

REQUEST FOR REDUCTION IN ALTERNATE SIDE STREET CLEANING FREQUENCY **IN CB #1** – Comments to be received on reducing the street cleaning frequency in Brooklyn Community Board No. 1.

Ms. John Mancuso, from the Department of Sanitation, provided a brief overview on street cleaning regulations, related the ratings of CB #1, and the process for making changes to reduce the frequency.

Ms. McKeever asked what the roll out timeframe for the posting the changes (new signs) once they are approved? Mr. Mancuso noted that it would be a three months at a time for the roll out. They would have to do sections at a time. DOT would have to make the new signs and post them.

A question was raised about what the changed frequency would be. Mr. Mancuso related that it would reduce the ASP to one day. District Manager Mr. Esposito clarified that it means one day a week on each side. Cars would have to move only two times a week instead of four times a week that they do now.

Ms. Cianciotta said that the community board and elected officials have worked on this for years. She hopes that reduction happens soon.

Ms. Kaminski asked about the ratings and how they treat areas around construction sites. Mr. Mancuso noted that the ratings are performed by the Mayor's Office of Operations and that the do not tell where they will be. It is a surprise where they are.

Dr. Barricelli asked about the street sweepers. Have they stopped using water when sweeping? Mr. Mancuso said that they do use water and it is for keeping down the dust. It is not for flushing the streets.

Rabbi Niederman spoke about the areas where there is construction going on. Streets there should be looked at differently when being rated. Mr. Mancuso related that he believes that they may use their discretion.

In addition to the briefing on street cleaning regulations (alternate side of the street parking) he answered various questions related to sanitation that were raised by board member and the public present at the meeting. There were no speakers on the item. Chairperson Ms. Fuller thanked Mr. Mancuso for providing the information.

<u>PRESENTATION:</u> <u>COMMENTS ON THE FISCAL YEAR 2019 BUDGET PRIORITIES</u> — Comments to be received regarding Expense/Capital Budget Priorities for Fiscal Year 2019 and Service Program Priorities. Chairperson Ms. Fuller called for speakers on the item. There was one at this time.

Mr. Chesler spoke about park issues for the budget. A written statement from the Friends of Bushwick Inlet Park was submitted for the record.

Mr. Weidberg, Budget Committee Chair, noted that the committee would meet next week to discuss the budget and priorities. The committee will meet on Wednesday, September 27th, at 6:30 PM, in the CB #1's District Office.

PRESENTATION: NEW ALTERNATIVES FOR CHILDREN INC. (N.A.C.) – In 2016, N.A.C. received a grant from the office of Children and Family Services to provide post adoption and post guardianship services to families that have legally adopted or obtained guardianship (not custody) for children they are parenting. Briefing on their resources and services. - by Jessica Chavarria, Bilingual Social Worker, Family Permanency, N.A.C. Ms. Samantha Callaghan provided a brief presentation and distributed material.

<u>PRESENTATION: WILLIAMSBURG COLLEGIATE CHARTER SCHOOL</u> – Briefing on the school and available seats in their 5th grade class. – by Isha V. Flores, Operations Fellow, Williamsburg Collegiate Charter School. Ms. Isha Flores provided a brief presentation and distributed material.

<u>PRESENTATION: GIRLS WHO CODE</u> – Briefing on their clubs, which are free afterschool programs for 6-12 grade girls, to use computer science to impact their community and join their sisterhood of supportive peers and role models. – by April Frazier, Regional Partnership Coordinator, Girls Who Code. Ms. Aya Gallego-Taveras, Community Partner Manager, provided a brief presentation and distributed material.

<u>PRESENTATION: COMUNILIFE</u> – Briefing on the organization and its development of an 89-unit affordable residential building, being constructed at 179 Throop Avenue on the campus of Woodhull Hospital and sharing information about connecting with the project for construction related jobs. – by Ellen Kackmann, Vice President, Real Estate and Asset Management, Comunilife. Chairperson Ms. Fuller called for the representative on the item. There was no presenter and the item was withdrawn.

PRESENTATION: NYC DEPARTMENT OF TRANSPORTATION: DOT CARSHARE

PROGRAM - In line with recent City Council legislation (Intros No. 267-A and 873-A) requiring NYC DOT to implement a two-year carshare pilot program, the Department will be dedicating parking spaces across the city exclusively for the use of carsharing organizations in the fall of 2017 – half in DOT-owned municipal parking facilities and half on-street in select pilot zones across the city. NYC DOT has identified two suitable zones with BK CB 1 for the pilot: The first zone will be within Williamsburg, bounded by Broadway to N14th St and the East River to Union Ave/ the BQE. The second zone encompasses parts of Williamsburg and East Williamsburg in an area bounded by the BQE to the west, Broadway/Flushing Ave to the south, Bushwick Ave to the east, and to the north, Metropolitan Ave / Grand Street east of Lorimer Street. NYC DOT is consulting with City Council Members, Community Boards, and the public when siting carsharing vehicles on-street in these select pilot zones. – by Alex Keating, Director of Special Projects in NYC DOT's Transportation Planning & Management Division will lead the presentation, with support from Laura MacNeil, Special Projects Manager. Mr. Keating presented on the pilot CarShare Program. He displayed various graphics by a computer generated PowerPoint presentation.

New York City Carshare Pilot – Concept and Context: Challenge of Continued Growth – the City must use its streets as efficiently as possible to move people and goods. This means increasing the share of residents who walk, bike, and take transit. DOT believes that shared-use mobility options such as carshare complement these goals. Highlighted were 7 key benefits of walking, biking and transit (improves street safety, enhances livability, promotes physical activity, expands travel choices, improves air quality, promotes equity of access, reduces carbon emissions).

CarSharing – an element of shared use mobility: providing reliable access to a car without having to worry about annual car insurance and maintenance bills. Members are provided access to an automobile for short-term use – usually by the hour or minute. The cost includes gas and insurance. (i.e. Zipcar, Car2Go, Enterprise Car, etc.).

Round-Trip CarShare: Zipcar (Avis Budget), Enterprise CarShare – Hourly or daily rentals. Borrow and return vehicles at same location. Focused in areas with private garages. Existing Service in NYC – Zipcar: 2,500 +cars/447 lcations. Enterprise CarShare – 320+cars/110 locations.

One-Way Carshare: Car2Go (Daimier), ReachNow (BMW) – Pick up a car at one location and drop it off at another (within zone). Users can park in any legal, inmetered parking space within zone.

Existing service in NYC – Car2Go: 550 Smart Cars, 27,000+ memnbers, ReachNow: - 250+ BMWs & MINI Clubmen.

The Benefits of CarSharing for NYC: Many US cities have run carshare pilots. The results from other cities show carsharing has measurable benefits.

CarShare Pilot: CarShare Legislation – City Council support for CarShare signed into Law March 21, 2017. Local Law 47 and Local Law 50.

Pilot Implementation:

- New Curbside Regulation and Multi-Lingual pedestrian signage.
- CarShare companies to clean parking spaces in place of alternate side regulations.
- No Standing Regulation NYPD can ticket and tow illegally parked car.
- At the own expense, companies can relocate illegally parked vehicles from CarShar parking spaces to a legal space within a ½ mile radius.

Schedule: Pilot Launch by year end 2017.


Williamsburg pilot zone

MOMENT OF SILENCE

Chairperson Ms. Dealice Fuller called for a moment of silence.

APPROVAL OF THE AGENDA

Ms. Cabrera made a motion to approve the agenda as written. The motion was seconded by Ms. Nieves and unanimously carried.

APPROVAL OF THE MINUTES

Rabbi Perlstein made a motion to approve the minutes as written for the Land Use Committee held Public Hearing of June 5, 2017 and the Combined Public Hearing and Board Meeting of June 13, 2017. The motion as seconded by Ms. Viera. The motion was unanimously carried.

PUBLIC SESSION – Liquor Licenses

Chairperson Ms. Fuller requested District Manager Mr. Esposito call the speakers on liquor licenses to come forward to present.

Mr. Emil Radoncic, 74 Bayard Street, spoke about their plans for an eating and drinking establishment on Bayard Street.

Ms. Rosemary Stevens, representing the residents of 67 North 7th Street, spoke in opposition to licenses for North 7th Street, noting that the liquor licenses and restaurants have compromised the quality of life for the long term residential tenants because there is too much activity for the block, noise pollution and overcrowding.

PUBLIC SESSION – 116 Bedford Avenue Rezoning Proposal

Chairperson Ms. Fuller asked for the speakers to come forward regarding the 116 Bedford Avenue Rezoning proposal.

Mr. John McDonald, resident, spoke in opposition to the proposal.

DCP # Cl70024 ZMK - 116 BEDFORD AVENUE, BROOKLYN, NY –IN THE MATTER OF an application submitted by 116 Bedford Avenue, LLC pursuant to Sections 197-c and 201 of the New York City Charter for an amendment of the Zoning Map, Section No. 13a, by establishing within an existing R6A District a C1-4 District bounded by North 11th Street, Bedford Avenue, North 10th Street, and a line 100 feet northwesterly of Bedford Avenue, Borough of Brooklyn, Community District 1.

Resolution: The committee felt the application failed to take in consideration the effect such plan would have on the residents and the current character of the immediate area. The committee found the residents' concerns were valid, especially regarding the need to attract increased community spaces contrasted with the danger of attracting a 'free-for-all' development of pubs and bars on this up to now heavily residential spot. The committee noted these concerns were in line with the standing concern of the full board that there has been an uncontrolled proliferation of bars and pubs. The committee felt that it has an obligation to acknowledge the valid concerns voiced against this application and voted unanimously to deny the application based on the above reservations. Landmarks Subcommittee – Ms. McKeever, Landmarks Subcommittee Char, submitted a written report that was distributed for review. She read the report and presented a resolution regarding the Landmarks Preservation Commission application for the building at 132 Calyer Street. 132 Calyer Street is a three family midblock 1870's wood frame house in the Greenpoint Historic District. The owner (who grew up in the house) wishes to make improvements to the façade. The proposed renovation is straight forward – the aluminum siding will be replaced by a wood composite siding previously approved by Landmarks, the aluminum windows, replaced with wooden windows and an elaborate cornice as well as decorative window trim and entry portico (all made of polyurethane but wood-like in appearance) installed to exactly match the 1940 tax lot photo. The proposed siding will

be Stonington Gray and the trim, a dark brown color called "Wenge." These colors were vetted by Landmarks. The owner shared an example of the siding along with a booklet describing the product. The option for a smooth finish found in the brochure rather than the rougher sample presented (simulating wood grain) would be preferable. It was noted that the owner and his architect began working with Landmarks last March. He is eager to complete the renovation before winter. They contacted CB1 in August. Because the issue did not make it to the September Land Use Committee meeting agenda, Trina McKeever, Landmarks Chairperson met with the owner at the site and presented the project and proposed resolution to the committee via email. There were no committee objections. Ms. McKeever made a motion to support the application for renovations with the following condition: that a smooth finish is chosen for the siding. The motion was seconded by Ms. Teague and carried unanimously.

At present, the City has allocated capital funds to start the remediation of the Bayside Fuel Oil site on Bushwick Inlet. Full funding for that remediation and for the remediation of the CitiStorage site are still required, as is funding for the construction of the Park itself.

It is our hope that the City will allocate capital funds towards the full remediation and construction of the park over the coming years, starting with FY 2019. FBIP will be advocating forcefully to make that happen and to make sure that the City continues to make progress towards fulfilling its ultimate promise.

We know that we can count on CB1's support, starting with making Bushwick Inlet Park your highest capital spending priority.
