Chairperson Michael Ien asked for a moment of silence for Firefighter Timothy Klein who died recently fighting a fire in Canarsie and for the victims of the Buffalo mass shooting over the

weekend.

REGULAR MEETING

Chairperson Michael len greeted everyone and introduced the Officers of the Board. He then opened the regular meeting of the Board and asked if there were any additions or corrections to the minutes of the Board meeting held on May 18, 2022. There being none, Chairperson Michael len asked for a Motion. Board Member Saul Needle made a motion that the Minutes be accepted as written. Board Member Valerie Woodford seconded the Motion and the Motion passed with 23 Yes Votes.

PUBLIC HEARINGS

Chairperson Michael Ien introduced Elyse Foladare, of Eric Palatnik, PC representing B.S.A. Calendar # 135-46-BZ - Premises affected - 3802 Avenue U, Block 8555, Lot 37 who provided a brief presentation on an instant Application filed pursuant to Section 11-411 of the Zoning Resolution of the City of New York, that seeks to extend the term, which expired on January 29, 2022, and amend a variance to remove the automotive station originally granted under B.S.A. Cal. No. 135-46-BZ on July 16, 1946. The Board of Standards and Appeals approved a gas station with an automotive repair shop in 1946. The amendment would allow for a gas station with a convenience store and no auto repair shop. The building is being enlarged by 900 sq feet to accommodate the convenience store and will stand at 3500 sq feet. Neighbors within a 1000 sq feet radius were notified. The applicant met with CB18's Planning and Zoning Committee to design a site plan that would not have a negative impact on residents. Elyse Foladare asked if there were any questions from the floor. Board Member and Marine Park Civic President Bob Tracey has no problem with them extending the variance, but he's not sure the neighborhood doesn't have any objections. Bob Tracey stated that there were no notices sent out. Elyse Foladare informed him that notices were sent out. DM Partnow said she received two objections from the residents. Bob Tracey felt that several blocks are affected by this and asked if 1000 sq feet of notification is the minimum requirement. Elyse Foladare explained that the minimum is 400 sq feet. Bob Tracey asked when this plan is scheduled to take place. Elyse Foladare explained the Board of Standards and Appeals approval will take about a year. Bob Tracey asked if the tanks that they're going to put in are in the ground already and have they done a test on the property. Elyse Foladare explained that they proposed new tanks, and a survey was done, and nothing problematic has come up. Board Member Barbara Bieber asked what the hours of operation will be. Elyse Foladare responded they would like it to be open 24 hours. Board Member Tom Hernandez Jr. asked if she could describe the convenience store. Elyse Foladare responded it would be a business where people can get everyday items. Alexandria Asaro, an area resident of East 38th Street between Avenue U and T, expressed concerns about traffic, air pollution and contaminated soil. Board Member Barbara Bieber suggested possibly putting in a speed bump on East 38th Street from Avenue U to V. DM Partnow explained that it is not that easy to get a speed bump. Alexandria Asaro asked if there are any other options besides speed bumps. Ed Pessotti explained that he lives on East 38th Street between Avenue U and V and it was recently changed to a one-way street with a bike lane and a curb cut. He said traffic will increase to turn into the gas station. Elyse Foladare asked whether CB18 can assist in getting the speed bump approved. Board Member Malynda Jordan-Dandridge asked how many parking spaces will be on premises. Elyse Foladare explained that it was approved as a gas station with 12 parking spaces and they're doing 14 and 1 handicapped accessible parking space in the front of the building. Board Member Malynda Jordan-Dandridge

replied only one handicapped spot is insufficient. Elyse Foladare explained that all the parking spaces are in front of the building and only one handicapped accessible spot is required. Board Member Malynda Jordan-Dandridge asked if there's a way to get two handicapped accessible spots. Elyse Foladare stated that they can ask the architect if they can have two. Board Member Malynda Jordan-Dandridge thanked her. Elyse Foladare thanked everyone for allowing her to present.

Chairperson Michael Ien introduced Michio Sanga, RA of Façade Architecture Inc., Representing B.S.A. Calendar Application #2022-23-BZ - Premises affected -1520 East 56th Street, Block 7900, Lot 53 who provided a presentation on an application for a variance, pursuant to Zoning Resolution (the "Z.R.") § 72-21, to allow, within an R3-2 zoning district, the construction of a detached two-story house with cellar, that does not comply with the zoning requirements for front yards (Z.R. § 23-45) and side yards (Z.R. § 23-461). Michio Sanga informed the Board that it's a triangular shaped house and is approximately 1860 sq feet and side corner with a garage and small yard in the back. This house is being built on an empty lot. It's a corner property and it was not being kept up by the owner because nobody was living there. They want to build a two-family house approximately 925 sq ft for upstairs and downstairs. Josephine Poloti Area Resident and Vice President of Mill Basin Civic Association explained that she lives across from the site and it's been an eyesore, and this will be a good thing for the neighborhood. Owner Edward Kowlessar stated that he received letters from neighbors who are very happy he will be building on the site. He is asking for the approval for a variance. Board Member Eugene Burshtein asked if they were denied approval from the Board of Standards and Appeals. DM Partnow stated that they just applied with the Board of Standards and Appeals.

GUEST PRESENTATIONS

Jovia Radix, Vice President of Kasirer Consulting, Representing Macerich, Kings Plaza introduced herself and introduced Dawn Simon, the Area Senior Marketing Manager and Emma Dawson, General Manager for the Kings Plaza Shopping Mall. Emma Dawson informed the Board that she oversees the property, and they are here to answer any questions that the community may have. Board Member Malynda Jordan-Dandridge said the area is very dark and suggested better lighting or more police presence at night. Emma Dawson said they have lighting around the property that they survey nightly. In terms of having police there it depends on their schedules. Board Member Barbara Bieber asked if they have an extensive camera system outside the perimeter of the building. Emma Dawson stated that she's not going to tell how many state of the art cameras they have but she'll say that they are able to assist the police in apprehending perpetrators. Board Member Paul Curiale stated that on behalf of the Mill Basin Civic Association they work closely with Kings Plaza and thanked them for their donations to the community and community events. He knows Kings Plaza cleans and sweeps their property and works closely with the 63rd Precinct. Board Member Tomas Hernandez stated that Kings Plaza's reputation of dangerous incidences have kept people away. Marketing themselves as a safe and great place to shop again will build their reputation and increase traffic. Dawn Simon explained that they've had issues at Kings Plaza mall which have been unfortunate but it's beyond their control. However, they've made tremendous strides in their Community Relations Program since she started in 2012. Kings Plaza is making improvements and bringing big name stores into the mall, one of which is Target. Jovia Radix added that they are in constant contact with the local elected officials and the District Manager whenever issues develop, or something is needed in the community. Steve Smith, a resident of East 57th Street, stated that all the donations and giveaways are nice, however, he agrees with Board Member Malynda Jordan-Dandridge that the lighting is very poor. Also, the Macy's escalator

is always broken. Emma Dawson stated that she believes she addressed the first issue in terms of the lighting and Macy's is one of their anchors and they're putting in a lot of money and there will be a lot of improvements. Tamara Marchall asked about attracting the youth in terms of jobs and summer jobs. Dawn Simon thanked her for the question and explained that they have job fairs at least one or two times a year. There will be another job fair around the holiday season. There are also job postings on their website www.kingsplazaonline.com. She also provided the names of their Instagram and Facebook pages which offer additional job opportunities. Venus Sutton asked if there are any small business opportunities. Jovia Radix explained that there are always opportunities to open a small store in the mall. An area resident asked if Kings Plaza would consider waiving the parking fee on certain days or times. Jovia Radix said that waiving the parking fee would be highly unlikely. Eileen Level mentioned that in the 1990's Kings Plaza had a movie theatre frequented by teenagers and young adults and wanted to know how Kings Plaza can socially engage our youth outside of work since malls are hot spots.

Eileen Level, Founder of PaleFO Cinema introduced herself and provided a brief presentation about the first outdoor cinema summer series at Bayview Houses. The cinema series will invite young people to curate and produce the event. Keeping teenagers and young people engaged can prevent youth gang activity. There is a lack of continued recreational activities for our young adults and teens between the ages of 14-24. Bayview Houses and Breuklen Houses will be using their spaces as outdoor cinemas. There will be a DJ, music, trivia, free giveaways and access for them to have social connectiveness without cellphones. There'll be opportunities to win gift cards from our local merchants thanks to the Rockaway Parkway Merchants Association. Sponsors are needed for the screenings whether that means purchasing the popcorn or candy concessions or help purchasing the license for the film. The \$8000 Summer grant from the Mayor's Office is dwindling down. To show one film to the public for free is about \$450 for that license alone. If anyone wants to support or sponsor, she can be reached at eleenleveal@gmail.com. It doesn't have to be a monetary commitment; it could just be helping her get more youth involved. She thanked everyone.

DISTRICT MANAGER'S REPORT – Sue Ann Partnow

District Manager Partnow greeted and thanked everyone for joining tonight and Provided the following information:

- 1. She attended the monthly District Managers Meeting hosted by Deputy Borough President Diana Richardson where the discussion focused on the needs of Community Board Districts.
- 2. She spoke at the Mill Basin Civic Association Meeting to update the residents on what's happening in Community Board 18. She was honored to discharge and install the officers of the Bergen Beach civic Association.
- 3. She addresses the family and friends of John Cortese, owner of the Golden Gate Market, at the street naming in his honor at Flatbush Avenue and Troy Avenue.
- 4. She took part in Senator Roxanne Persaud's Spring Festival in Canarsie Park and then joined Council Member Farah Louis' Spring Festival in Amersfort Park. Easter egg hunts, face painting, balloons and giveaways and all-around fun.
- 5. She attended the Inauguration of Borough President Antonio Reynoso

- **6.** She provided updates at the 63rd Precinct Community Council Meeting and the Mill Island Civic Association.
- 7. She collaborated with Assembly Member Jaime Williams to present a ceremony on the children of the Holocaust. She thanked Council Member Mercedes Narcisse, State Senator Roxanne Persaud, District Leader Frank Seddio, the Simon Wiesenthal Center and the JCRC for their participation and meaningful words.
- 8. She met with the 69th Precinct, Parks Department, and the organizers of the Annual Pop Smoke Event in Canarsie Park scheduled for Wednesday, July 20th to discuss concerns, safety and respect for the homeowners surrounding the park.
- **9.** She spent this past Sunday morning with Assembly Member Jaime Williams and her staff distributing compost to the community. Many community residents came to pick up compost and flowers. A great hobby and kudos to those with green thumbs.
- **10.** The Department of Transportation is looking into requests for traffic signals on Avenue N and East 55th Street and Avenue T and East 63rd Street and checking on possible medians for East 69th Street between Avenues U and Y to curtail speeding and cars doing donuts.
- **11.** The NYC Department of Sanitation and the 69th Precinct did a tag and tow operation at Remsen Avenue and one at Rockaway Parkway and summonses were issued to local body shops for leaving cars on the street.
- 12. The NYC Parks Department reported Four Sparrows Field which is located next to the old Toys R Us property was cleaned up last week. There will be a new comfort station in Canarsie Park at the skate park at Paerdegat Avenue. The Amersfort Park Fountain is in the process of being cleaned out to be up and working for the upcoming warm months.
- **13.** Brookdale Hospital is hosting a street fair on Saturday, June 11th right in front of the hospital.
- **14.** Michael Benjamin, Representing State Senator Roxanne Persaud, Kim Robinson, Representing Council Member Mercedes Narcisse, and Sabrina Dieujuste Representing Farah Louis provided updates from their offices.
- **15.** The NYC Department of Transportation will implement Vision Zero Safety Improvements along Kings Highway between Avenue J and East 98th Street. (Install left turn signals, add painted median tips, add painted curb extensions, ban low volume left turns, and upgrade corridor markings).
- 16. The NYC Department of Design and Construction will be starting construction on the Jamaica Bay Greenway-Canarsie Pier Connector Project. This project involves the construction of a two-way grade separated greenway path along Shore Parkway service road, Rockaway Parkway and Canarsie Veterans Circle.
- 17. The NYC Department of Parks will be upgrading Sunners Playground at East 49th Street and Avenue H to include a water play area, separate play areas for 2-5-year old's and 5-12 year old's, new swings, a drinking fountain, and seating area. Power Playground at Utica Avenue and Avenue N has been closed since this past Monday, May 16th to begin Phase I of construction which will include a skate park in place of the bocce court that is there now. There will be a Zoom meeting tomorrow evening for

- community input on Phase 2 of Power Playground. If you would like to participate in the zoom, please call the Community Board Office and give us your email and we will send you the link.
- **18.** Whether you live on a block with Alternate Side or shop in an area with Alternate Side Parking, please be aware that beginning on July 5^{th,} Alternate side Regulations for street cleaning will be restored to Pre-Pandemic frequency.
- **19.** Congratulations to Council Member Mercedes Narcisse on the graduation of her daughter.
- **20.** Happy Belated Mother's Day to the moms, grandmothers, great grandmothers, aunts, sisters, and friends as we celebrated all the women that made a difference in our lives.
- **21.** A quick announcement, next months meeting will be held outdoors at the John Malone Center on June 29th. There will be no virtual option for that meeting. Details will be sent via email and will be on the Community Board 18 website.

District Leader and Board Member Frank Seddio informed the Board that this is reapportionment year when new lines are drawn for the various political districts that we have in our community. Community Board 18 is basically represented by two main Assembly Districts which is the 59th and the 41st the lines for the 59th and 41st Assembly Districts have pretty much stayed the same. There is some controversy about the fact that we're going to have two Primaries this year. On June 28th we will be voting for Governor and Lieutenant Governor for the State of New York, and this is a Democratic Primary and a Republican Primary as well. Early Voting begins June 18 and ends June 26th. The two locations in Community Board 18 are 5201 Avenue N and IS 68 on East 82nd Street and Avenue J. He continued to explain about the different local challenges and the new lines for Congress and the State Senate. He explained how large CB 18 is and that we are the largest geographical board in the City of New York with more parkland than Central Park and Prospect Park combined. No other community has what we have, it's unique. Our community is like a small town in a big state, and it works because we're mostly 1-2 family homes with very few developments. We are just middle-class people trying to take care of educating our children. keeping our neighborhoods safe, and working hard at our jobs. He informed the board members that he's going to do something special next month for the Board Members as an appreciation for all they do. Information will follow.

Officer Ronette Benjamin, 63rd Precinct, greeted everyone and informed the Board that on May 17th there was a suicide at the Days Inn Hotel located at 1729 East 49th Street. This would be the second suicide since this hotel has been in existence. She provided event updates, and precinct crime statistics. Steve Smith stated that he is very disappointed in the 63rd Precinct. He has called 311 repeatedly to report abandoned vehicles and nothing is done by the police. DM Partnow suggested that he call the CB office because we work together with the Precincts and Sanitation to tow derelict vehicles. Steve Smith also asked what is being done about the dollar vans. They park all over the streets, cause traffic backups and don't get ticketed. They're eventually towed and right back on the streets. He complained about gun violence, school shootings and people riding around on ATV's. Officer Benjamin invited him to attend the next 63rd Precinct Community Council Meeting being held on May 23rd.
