Board Member Jim Buchanan led the Pledge of Allegiance.

REGULAR MEETING

Chairperson Michael Ien opened the Regular Meeting at 7:05 P.M. He introduced the Officers of the Board and asked if there were any additions or corrections to the Minutes of the Special Meeting for the Election of Officers and the Regular Meeting of the Board held on January 19, 2022. There being none, Chairperson Michael Ien asked for a Motion. Board Member Michael Benjamin made a motion that the Minutes be accepted as written. Board Member Malynda Jordan-Dandridge seconded the Motion and the Motion passed unanimously with 38 Yes Votes.

GUEST PRESENTATION

Chairperson Michael Ien introduced Randy Peers, President & CEO of Brooklyn Chamber of Commerce who is a lifelong resident of Community Board 18. He recognized Gabriel Cirio, Matalya Figueroa and Gil Cygler who is an Executive Member at The Brooklyn Chamber of Commerce along with a few other team members that will be coming later to bring some flyers as well. Randy Peers provided a brief presentation on what they've done in terms of business recovery and what they could do to help and support the small businesses. He reported that with Omicron waning, many businesses are coming back, and people are starting to patronize restaurants once again. Brooklyn Chamber of Commerce had an idea early on that no matter what the recovery looked like and no matter what resources were going to be put on the table for small businesses, small businesses were going to need help accessing those resources. They launched the small business resource network funded by the Peterson Foundation, a citywide program that enabled them to put business recovery specialists in every neighborhood across the city. Here in Brooklyn, they have eight recovery specialists. They had two that specifically worked with restaurants and the rest that are geographically focused on different communities to access help. They have Legal assistance since businesses have issues with rent and renegotiating leases. They are working to do merchant organizing and merchant support on Rockaway Parkway and on Flatlands Avenue in partnership with Noreen Medas from the Rockaway Parkway Merchants Association. They also assist with holiday lights in Canarsie, along Avenue U. Marine Park and Homecrest. There is small business lending through the Brooklyn Chamber of Commerce. There are also micro loans with a big infusion of capital from the Joe and Clara Tsai Foundation and the owners of the Brooklyn Nets to do social justice lending. Social Justice lending finances minority owned businesses. Each loan is a maximum of \$15,000 with no interest. These are recovery loans for businesses that couldn't access financial support by other means. They have other lending as well as partnering with other CDFIs. The Social Justice lending program has really been the signature program for recovery especially for minority owned businesses. One of the things that historically kept people out of financing is credit scores, collateral, and guarantors and these three conditions do not apply with these recoveries. They are hoping to extend lending beyond recovery loans to new entrepreneurs. Many businesses can't find employees, and supply chain issues are impacting product shipping. The Chamber of Commerce is here to support businesses and encourages people to shop locally. TriniJam Bk on East 95th Street and Flatlands Avenue opened during the pandemic. TriniJam Bk is an amazing restaurant with murals on the wall by a local artist. They're going to be getting a small business grant, but they can use your support. Randy Peers thanked everyone for their time and asked for questions from the floor. 1st Vice Chair Saul Needle asked if someone was interested in characterbased lending and someone from the community vouched for the person receiving funds that it does not mean co-sign and they're not legally responsible. Randy Peers stated that it does not mean co-sign but the theory behind it is that someone of stature in the community is basically giving a seal of approval that this business had been operating, they know these guys and they need to

help and they endorse them but it's not a legal document. Chairperson Michael len stated that small businesses are the backbone of their communities and he himself frequents a bodega around the corner from his house almost every day as opposed to going to the Gateway Shopping area. Michael Benjamin, Representing State Senator Roxanne Persaud stated that today the State Senate Majority passed a package of bills that helps small businesses. Randy Peers stated that he hopes that the State Grant program makes more businesses eligible. Yoselin Genao Estrella asked whether the Chamber of Commerce is working on projects to revitalize the Avenue L corridor without displacing existing small businesses. Randy Peers stated that right now they are not working on Avenue L in terms of commercial revitalization. Their business recovery specialists are working with the individual businesses on Avenue L. They are doing neighborhood development commercial revitalization on Rockaway Parkway and Flatlands Avenue. They are working with the individual businesses on Avenue L through their business recovery specialists. Any business in Brooklyn can access a business recovery specialist and a small business resource network at the Brooklyn Chamber of Commerce at www.brooklynchamber.com and they're happy to support them. Randy Peers informed the board that he has already done corridor work with Council Member Mercedes Narcisse. They know where the challenges are because the Council Member and her staff call him directly to let him know the businesses that are experiencing issues. That's the type of partnership that works. Council Member Mercedes Narcisse stated that the Brooklyn Chamber of Commerce has a good team.

DISTRICT MANAGER'S REPORT – Sue Ann Partnow

District Manager Partnow provided the following information:

- 1. She greeted and thanked everyone for joining tonight. She informed the board that unfortunately Borough President Antonio Reynoso, who was scheduled to be here this evening had a scheduling conflict and will try and reschedule with the board for next month.
- 2. She attended a Cabinet Meeting hosted by Borough President Antonio Reynoso where it became apparent to everyone in the room that he has a lot of energy and has fresh ideas on how to enhance our borough and strengthen our Community Boards.
- 3. Transportation Chair Gil Cygler and herself attended the Community Board Organizer of South Brooklyn and Staten Island Meeting on Transportation issues in the boroughs and the important roles of Community Boards.
- 4. This month she also attended several meetings on Gun Violence Prevention. She joined Borough President Antonio Reynoso, the NYPD, our Local Council Members Mercedes Narcisse, and Farah Louis, along with Violence Interrupter Organizations and the Clergy. The 69th Precinct Community Council also held a Stop the Violence Meeting with similar ideas to organza events and come up with different ways to keep young people engaged and out of trouble.
- 5. As all of you are aware, Kings Plaza had a serious incident and their management met with Council Member Mercedes Narcisse, State Senator Roxanne Persaud, Assembly Member Jaime Williams and herself about keeping patrons safe. She invited a representative from Kings Plaza to come to our meeting and address members and the community on their plan to keep shoppers safe. They'll be joining us at our upcoming

- meeting in March with their safety plan.
- 6. She joined Sal Calise Chair of Planning and Zoning at a meeting with the NYC Department of Homeless Services and our local civics and block association representatives about the property at 1427 Ralph Avenue. NYC Department of Homeless Services is putting together an informative presentation for our next board meeting.
- 7. She had the pleasure of being invited to four different senior centers this month and she's happy to say that their members are back and in person enjoying activities and lunch again.
- 8. Board Member and Bergen Beach Civic President Sal Calise. Board Member and District Leader Frank Seddio and her are closely monitoring the property on East 69th Street and Avenue X to make sure the property is leased to a company that respects the residents living across the street.
- 9. Last week she presided over her first Community Board Cabinet Meeting. Assembly Member Jaime Williams was in attendance and thanked our police officers who are facing unbelievable pressure during these difficult times. She also noted that she is working closely with the precincts and Community Board 18 on illegally parked cars with out-of-state plates and addressing the issue of double-parked cars and littering at the bus depot on Fillmore Avenue.
- 10. Deputy Inspector Genevieve Isom also spoke about the abandoned trucks, buses and RV's in our area and will be requesting a large city tow truck to help clean them up. The 63rd Precinct is also checking out a vacate order at a house on Avenue K that is currently being occupied by several people using space heaters.
- 11. Police Officer Samuel Maria of the 69th Precinct reported on the guns retrieved at a shooting in Canarsie. The officers involved suffered minor injuries.
- 12. Brookdale Hospital and Community Hospital reported that COVID 19 admissions are down. Community Hospital made a request to the NYC Department of Transportation for angled parking for both ambulances and visitors since they have no parking lot.
- 13. Frank Fontana from The NYC Department of Buildings has been assisting the community board in obtaining information on the old Toys R Us property owner. The building is an eyesore as you exit the Belt Parkway and drive north on Flatbush Avenue. Checking with the NYC Department of Finance was suggested for the most current information on the owner. Frank Fontana also spoke about the new gas law banning gas powered heat and appliances beginning in 2023.
- 14. She asked National Grid representatives to give more details when beginning projects here in Community Board 18. Start dates were vague and more information is needed to alert residents. The representatives informed everyone about their consumer and volunteer programs and will do a presentation about the programs at one of our upcoming board meetings.

Representing State Senator Roxanne Persaud, and Yehudda Schupper Representing Assembly Member Helene Weinstein gave updates from their respective offices.

- 16. Although the month of February is short there is much to celebrate. President Gerald Ford officially recognized Black History Month in 1976, calling upon the public to "seize the opportunity to honor the too-often neglected accomplishments of Black Americans in every area of endeavor throughout our history." Today, Black History Month is a time to celebrate and honor the contributions of Civil Rights Pioneers, Inventors, Scientists, Teachers, Politicians, and more.
- 17. Happy Chinese New Year. It is the year of the Tiger, known for strength, bravery, and good luck.
- 18. Happy Valentine's Day and coincidentally it is also Heart Health Month. So, cut back on all that chocolate you received and make a date to see your doctor.

She ended by thanking everyone for taking the time to join us tonight.

Council Member Mercedes Narcisse, 46th Council District greeted and thanked everyone for coming out this evening. She mentioned that it has been a very hectic and busy month for her. She thanked District Manager Sue Ann Partnow for doing the work that she's been doing. She thanked Randy Peers from the Brooklyn Chamber of Commerce for the great work that he has been doing with the businesses throughout the 46th Council district. She informed the board that she serves on the Transportation and Infrastructure Committee and was appointed Chair of the Hospitals Committee where she hopes to create access to healthcare in our community and in at-risk areas. She recently joined Mayor Adams at the grand opening of the Gotham Clinic located on Broadway. The Council Member went on to say that healthcare should be our right and shouldn't be based on gender, economic status, or anything else. COVID has highlighted the problems that we face in our communities, it is time to move healthcare into the 21st Century. On another subject, the Council Member is introducing legislation on gun violence. She also spoke about food insecurity, and the Open Restaurants/Sidewalk Café's Amendment. Her office is located at 2424 Ralph Avenue. She acknowledged Saye Joseph her Chief of Staff and Kim Robinson from her office and provided program and event updates.

Capt. Khandakar Abdullah, Commanding Officer 69th Precinct, greeted everyone and provided program and event updates, precinct crime statistics and answered questions concerning those statistics. Board Member Rosamond Alvaranga asked for Police on Rockaway Parkway and Glenwood Road when riders come off the subway. Capt. Khandakar Abdullah said it's noted, and that location has been on his radar due to a recent shooting.

Board Member and 59th A.D. District Leader Frank Seddio greeted everyone and stated that tomorrow the Democratic Party will be nominating candidates for the offices of Governor, Lieutenant Governor, Attorney General, NYS Comptroller, United States Senate, at the NYS Convention. He informed everyone that June 28, 2022 is Primary Day and there will be local races for State Senator, Assembly and State Committee Members/District Leaders. He continued with an explanation of the process. He quickly mentioned the prior bus company issue on East 69th Street, the building going up on Strickland Ave and the street conditions in Canarsie, Mill Basin, Bergen Beach and Marine Park. He has been appointed as Chief Advisor to the Commissioner of Transportation. If you have a problem with the DOT let District Manager Partnow know. He

addressed other quality of life issues in the area.

COMMITTEE REPORTS

<u>PARKS COMMITTEE</u> – Nancy Walby, Chairperson Chairperson Walby provided the following information:

- 1. NYC Parks, in Partnership with the NYC Department of Transportation held a virtual public meeting last night, Tuesday, February 15, 2022, to provide updates on the conceptual planning process of the Destination Greenways project in Brooklyn. Since this project is still in the conceptual stage no funding has been secured yet. The project, which stretches from Owl's Head Park along the shoreline adjacent to the Belt Parkway provides access to the Coney Island beaches and includes many repairs, upgrades, and new amenities and has been divided into 10 to 11 smaller projects/phases. Each of these smaller projects has an estimated cost anywhere from \$5 million to over \$20 million. It is anticipated that the planning stage will be finalized sometime this year, so the project can move to the next stage and is looking for funding from public and private sources.
- **2.** A similar virtual meeting was held last week to provide updates for the Destination Greenways project in Queens.

Chairperson Michael Ien introduced State Senator Roxanne Persaud who greeted everyone and provided a list of program and event updates. Board Member Malynda Jordan-Dandridge asked if State Senator Roxanne Persaud could add in her newsletter the property tax discount for homeowners. State Senator Persaud stated that they can list the property tax discounts and stated that she is hosting a property tax webinar on the 24th to talk about property taxes and the benefits for homeowners. Board Member Malynda Jordan-Dandridge asked if she knows if there are property tax discounts for homeowners who have people with disabilities living in their household even though their name is not listed as an owner. State Senator Persaud replied no and that all the property tax discounts are for the property owners. However, there are other resources for someone living in a household based on their disability and they can give all that information out.

Chairperson Michael len introduced D.I. Genevieve Isom, Commanding Officer 63rd Precinct. The D.I. provided program and event updates as well as precinct crime statistics. She mentioned that the 63rd Precinct is experiencing a crime increase for both the 28 day and the year to date periods. There has been an uptick in GLA's and robberies.

Council Member Farah Louis greeted and wished everyone a Happy Black History Month and a Happy Lunar New Year and provided a list of program and event updates. She's been working closely with NYPD and the District Attorney's office and a few agencies to address the anti-Semitic attacks that have been happening in the Community Board 18 area as well as Community Board 14. There's also been an uptick in gun violence in both Council District 45 and 46. She met with Council Member Narcisse, Borough President Reynoso and DM Partnow and she is very

grateful for their support. You'll hear more information soon about how they plan to address the gun violence plaguing our communities. Her office is working with the Department od Sanitation on manual litter patrol. Our job is to keep our community safe and clean. She asked if anyone had any questions or concerns or would like to partner with their office. She provided her office contact information and looks forward to seeing everyone next month and to be safe.
