Board Member Jim Buchanan led the Pledge of Allegiance.

REGULAR MEETING

Chairperson Michael len called the meeting to order and asked if there were any additions or corrections to the minutes of the Board meeting held on November 16, 2022. Board Member Jibreel Jalloh asked for a correction to the minutes as his attendance was not recorded. Board Member Sharon Borno made a motion that the minutes be accepted with the correction. Board Member David Price seconded the motion. The motion passed with 31 Yes Votes.

Chairperson Michael Ien introduced the Executive Board, 1st Vice Chair Greg Borusso and 2nd Vice Chair Maria Garrett, Secretary Barbara Bieber and staff District Manager Sue Ann Partnow, Assistant District manager Dorothy Paul and our Community Assistant Gail Fazio.

COMMITTEE REPORTS

Chairperson Michael len explained that our first order of business is taking a Re-Vote on the Capital & Expense Budget Submissions for FY 2024 and turned the floor over to Budget Committee Chair Barbara Bieber.

BUDGET COMMITTEE – Barbara Bieber, Chairperson

Chairperson Bieber explained that the board will be taking a Re-Vote on the 2024 Capital & Expense Budget submissions for the Public Hearing that was held on October 27, 2022 since it was determined that a quorum of the Community Board 18 members was not present. Chairperson Bieber made a motion to accept the Capital & Expense Budget Submissions for FY 2024 as they stand. Board Member Donald Cranston seconded the motion. Chairperson Bieber proceeded to do a roll call. The motion passed with 32 Yes, 2 No, and 1 Abstention Votes.

Board Member Elaine Reid asked to be reassigned from the Transportation Committee to the Social Services Committee since she is a licensed clinical Social Worker. Board Member Denise Gordon explained that she's a new member and just wanted to follow up on Board Member Reid's statement of how individuals are placed on Committees. Chairperson len explained that committees are selected at his discretion. District Manager Sue Ann Partnow explained that new members were put on Committees to fill vacancies of members that were not reappointed. DM Partnow said that a survey will be sent to Board Members requesting their preference for Committee assignments.

Chairperson Michael Ien introduced Nominating Committee Chair Gardy Brazela.

NOMINATING COMMITTEE – Gardy Brazela, Chairperson

Chairperson Brazela presented the nominees for the Slate of Officers for Community Board #18 for the calendar year 2023:

Chairperson Brazela asked for further nominations from the floor for the position of Chairperson, 1st Vice Chairperson, 2nd Vice Chairperson and Secretary. There being no further nominations, the nominations for Chairperson, 1st Vice Chairperson, 2nd Vice Chairperson and Secretary of Community Board #18 were closed. Chairperson Brazela asked for a Motion to close the nominations for the slate of Officers for Community Board #18 for the calendar year 2023. Board Member Malynda Jordan-Dandridge made a motion. Board Member Sal Calise seconded the Motion. The Motion passed with 35 Yes Votes. Chairperson Brazela announced that the Election of Officers for 2023 will take place at a Special Annual Board Meeting on January 18, 2023 prior to our regularly scheduled January Meeting.

PUBLIC HEARING

Chairperson Michael len opened the Public Hearing and called upon Board Member Frank Seddio to conduct the Public Hearing on the issue of the proposed parking meter installation on Quentin Road from East 37th Street and Marine Parkway and Avenue S. Board Member Seddio thanked the many residents who showed up to express their concerns. Brooklyn Deputy Borough Commissioner Claudette Workman and David Stein, the Director of Parking Planning and Policy for the NYC Department of Transportation (DOT) explained that they have received some concerns and complaints about meter installation on Quentin Road, which is currently on hold. DOT said they received requests from several business owners on Quentin Road and explained that they are here to listen to what everyone has to say and report back to DOT. Several area residents expressed their concerns with the proposed installation of Parking Meters along Quentin Road corridor. One concern was parking for teachers at PS 222 once these 40 parking spots are taken away to install meters. Brooklyn Deputy Borough Commissioner Claudette Workman explained that the principals can request parking passes for the teachers. David Stein explained that the NYC Department of Education can authorize parking by issuing permits. Board Member Barbara Bieber explained that she worked for a school and the NYC Department of Transportation issues parking passes, and the principal decides if they want to distribute it to their staff. Board Member Barbara Bieber stated the whole side of the school is underutilized and staff should utilize the entire parameter of the school where it says, 'No Parking from 7 AM to 4 PM". First Vice Chair Greg Borruso inquired about where the initial request came from because none of the people, he spoke with want the meters. Brooklyn Deputy Borough Commissioner Claudette Workman stated that the request came from the previous administration. A Marine Park resident living on East 36th Street off of Quentin Road went to businesses along the Quentin Road corridor showing the owners the DOT letter. The business owners said they never requested meters. Brooklyn Deputy Borough Commissioner Claudette Workman said they don't need any further discussion on the matter because it's very clear that the meters are not wanted. Board Member Frank Seddio met with the 1st Deputy Commissioner and made it very clear that there's not going to be any meters installed on Quentin Road. Michael Benjamin, Representing State Senator Roxanne Persaud, thanked Board Member Frank Seddio for holding that meeting. Board Member Frank Seddio made a motion that Community Board 18 stands with the Marine Park community and opposes the installation of meters along Quentin Road

from East 37th Street and Marine Parkway and Avenue S. Board Member Sal Calise seconded the Motion. The Motion passed with 31 Yes Votes.

CHAIRPERSON REPORT – Michael len

Chairperson len announced the members he appointed to the By-Laws Committee, Frank Seddio, Chairperson – Members: Ian Gaynor, Michelle Sealey, Grace Zwillenberg, and Ernest Borno. Board Member Frank Seddio mentioned that if any board members have any comments and recommendations for changes to the Bylaws to please contact the Community Board Office. Board Member Denise Gordon asked where she can send her recommendations. District Manager Sue Ann Partnow advised her to email them to the office.

Council Member Farah Louis greeted everyone and provided updates, community events, Holiday wishes. She commented on the Public Hearing with the NYC Department of Transportation that was held earlier. Last year DOT wanted to install more parking street signs around Quentin Road. She worked with the JCC of Marine Park and stopped the process. She's happy that the board voted tonight to oppose the parking meters especially on blocks that have homes. She everyone for voicing their concerns. She thanked District Manager Partnow for supporting some of the initiatives that she's had in the last couple of weeks for young people in our community. Board Member Barbara Bieber asked if the request for the installation of the parking meters had a timeframe. Council Member Farah Louis said that both her and Council Member Mercedes Narcisse's will send an official letter to DOT on behalf of the community that they oppose the installation of meters on Quentin Road and cc the Community Board on it.

Highlights from October Community Board 18 Cabinet Meeting:

- Brookdale Hospital reported 500 thanksgiving baskets were distributed, plus 30 turkeys to families in need. There will be a holiday food distribution on December 21st at the Kahn Auditorium. Phase 1 of construction for the new trauma area & waiting room will begin Feb. 2023
- DDC (Dept. of Design & Construction)— paving of the last 2 blocks in Bergen Beach before the holidays. Any odds and ends will be dealt with in the spring.
- 69th Pct. Capt. Abdullah increase in robberies around Canarsie & South Shore H.S. various youth programs being offered at the Pct to engage young people and keep them off the streets and out of trouble. Support for domestic violence victims. Slight increase in GTA (grand theft auto). Shootings and violence decreased. Community clean up at Glenwood Rd. From Rockaway Pkwy. to East 95th Street. 69th Pct. Community Council Toy Giveaway at Pct. On Saturday, December 17th.
- Millennium Dev. Corp. Paul Curiale reported on community events.
- 63rd Pct. continuing tow operations. Black Friday at Kings Plaza went well with no incidents reported. Collection and donation of toys for a local children's hospital.
- Mayor's Office of CAU (Community Affairs Unit) smoke shop enforcement through DCWP (Dept. Of Consumer & Workers Protection) and the Mayor's Office. Violations will be issued for selling tobacco products without proper licensing. In an effort to combat large trucks and trailers parking on city streets, the mayor's office is trying to coordinate using big store parking lots to house these large vehicles for a fee.

- DOB (Dept. of Buildings) all buildings that house 3 families or larger must have their gas piping systems inspected by a licensed master plumber every 4 years. This went into effect January 1, 2020. There is also a homeowner's relief program, any violations that have been corrected will not be penalized.
- FDNY fires increase at this time of year. They remind everyone to be cautious during the winter months and holiday season when lighting candles, using space heaters and multiple plug ins.
- Sanitation cleaning up streets throughout CB 18 for other agencies responsible for those areas. They have salt spreaders on the streets practicing for any expected snow or ice storms.
- Parks the Salt Marsh, Sunners Playground and the Canarsie park comfort station are all in progress.
- Daniel Heredia representing Council Member Farah Louis gave an update on upcoming events and explained redistricting. Mike Benjamin representing State Senator Roxanne Persaud gave an update on events and explained the state senators redistricting changes.

IN & AROUND CB 18

- After I Contacted Sanitation, new Trash Receptacles were installed on the Rockaway Parkway Corridor
- Met with residents on Flatlands 7th St. after the Governor's Office of Storm Recovery completed the resiliency project to discuss their options for damages. I put them in touch with our liaison from the Comptroller's office to guide them through the process.
- The bench at the Utica Ave. & Ave. M bus stop was replaced after CB 18 reached out to the DOT.
- Contacted Verizon to remove an old phone booth in Marine Park. They sent out a team to inspect and will be removing the old phone booth before the end of the year.
- An update on the shelter at 108-75 Avenue D Dept. of Homeless Services has opened the Legacy Family Residence for families with children. Volunteers of America, Greater New York is the provider. The site will have 98 units that will be used.
- The office of the Brooklyn Borough President wanted me to remind our members that attendance at Community Board meetings is very important. An attendance spread sheet is emailed to all the Community Boards from the Borough President's office.

- 1. Mulchfest, December 26, 2022 January 8, 2023. Wrap up your holiday season and say goodbye to your tree at Muchfest. Join NYC Parks and NYC Dept of Sanitation in the NYC holiday tradition of recycling Christmas trees (https://www1.nyc.gov/assets/dsny/site/services/food-scraps-and-yard-waste-page/christmas-trees). Put on your boots and haul your tree to a Mulchfest location (about 23 in Brooklyn) from December 26th through January 8th. On January 7th & 8th, DSNY will host a "Chipping Weekend" at some of the Mulchfest locations, where you can pick up free chipped trees for mulch if you bring your own bag. This is for residents only, no businesses please. In CB18 you will be able to pick up free mulch in Marine Park on January 7th & 8th, 10am 2pm.
- **2.** Also, weather permitting, DSNY will collect and compost trees left at curbs from Friday, January 6 January 14
- 3. There are lots of indoor and outdoor activities and events in our parks during the winter months. Lots of things to keep park visitors of all ages occupied and most of them are free! Check them out by calling 311 or visiting the Parks website at nyc.gov/parks.

Chairperson Tomas Hernandez Jr stated that the Community Board notified the Board Members, the local elected officials, civic associations and the 63rd and 69th Precinct about the SLA Applications received from JP Canes Inc., Bill's Bar, Blueprint 265 Management LLC., C'Zen Restaurant, Verdure Inc., TBD, Allure Restaurant & Bar Inc., Allure Restaurant & Bar, Hudson River Yacht Club Inc., N/A, The Juicy Box Bar LLC, The Juicy Box. Objections were received for both The Juicy Box Bar LLC, The Juicy Box, 2281 Nostrand Avenue, 11210 and Blueprint 265 Management LLC., C'Zen Restaurant, 4410 Avenue H, 11234. The Juicy Box Bar LLC, The Juicy Box, has a history of neighborhood complaints, a suspended license in Fall 2020 due to noncompliance with the city rules in regard to reopening during the COVID 19 pandemic, shooting resulting in police actions, unruly and destructive patrons, destruction of neighboring properties as well as displaying public drunkenness, and continuing to do business past 4am on all nights of the week. This establishment creates a general negative impact on the adjacent residential community-at-large. After due consideration, and objection from the NYPD, and the negative sentiments voiced by the area residents, it is in the best interest of the community that Community Board 18 recommends denial of this Application based upon a history of issues at that location. In reference to Blueprint 265 Management LLC., C'Zen Restauran – Assembly Woman Helene Weinstein's Office, the local civic associations, and the neighboring residents object to the Method of Operation change which would amend their original SLA License to include the use of the backyard space to serve Liquor, Wine, Beer & Cider, recorded and live music on their Patio/Deck, and the modification of their closing time, from 2am to 4am. While Assembly Member Weinstein's Office, the civic associations and the neighboring residents are not opposed to the establishment renewing their license to operate they are opposed to the Method of Operation Change.

Chairperson Hernandez asked if the applicants or a representative for Blueprint 265 Management LLC., C'Zen Restaurant, and The Juicy Box Bar LLC, The Juicy Box, was in attendance. The 63rd and 69th Pct were no longer present. The Juicy Box Bar LLC, The Juicy Box, was not in attendance. Natalie Aidinov Representative for Verdure Inc., TBD, and Kwame Mack the owner of Blueprint 265 Management LLC C'Zen Restaurant and his attorney Frank Palilo were present. Frank Palilo explained that there seems to be a misunderstanding on the Method of Operation Change as it's only to add live music and DJ to the restaurant and just to extend their closing hours from 2am to 4am on Thursday, Friday and Saturday. There is no change to the outside area, and nothing is being added to the backyard area. DM Partnow informed them that the Community Board received emails from residents opposing any change to their closing hours and live music. Frank Palilo asked that the board just get the resolution right because they're not asking to add live music and DJ to the outside. Board Member and Flatlands Flatbush Civic Group Member Violine Roberty said they do not have an issue with the establishment operating, they have an issue with them operating until 4 am. The establishment shares a backyard with the neighbors and that it's not fair to have music until 4 am. Board Member Sal Calise stated, if it isn't broke don't fix it. Frank Palilo stated that three years ago the Community Board was dead set against his client's application, and he appreciates Board Member Violine Roberty saying that they've done a good job. Frank Palilo argued that his client gained the trust of this Community Board three years ago and deserves the opportunity to grow his business. Board Member Kenny Jean Baptiste stated that they must speak for the neighborhood and the neighborhood does not want the closing time to change to 4 am. The residents want the restaurant to thrive but not at the applicant's proposed method of change. Board Member Sal Calise stated that if the establishment is doing good, how is business going to go up in two hours. Board Member Frank Seddio suggested that the board table the application for Blueprint 265 Management LLC., C'Zen Restaurant until next month's meeting so that the owner reconsider their request and come back with a better solution. Kwame Mack the owner of Blueprint 265 Management LLC., C'Zen Restaurant expressed that they've been there for three years and would like to remove all stipulations as far as live music. Board Member and Flatlands Flatbush Civic Group Member Violine Roberty stated that they have strong block and civic associations and could have discussed this, but this is the first time they're hearing about the method of operation change. Chairperson Hernandez said the Planning & Zoning Committee will set up a meeting to discuss the matter further.

There being no community opposition for the following establishments, Chairperson Hernandez asked for a motion that Community Board 18 recommends approval of the SLA Applications received from JP Canes Inc., Bill's Bar, 6326 Avenue N, 11234, Verdure Inc., TBD, 7804 Flatlands Avenue, 11236, Allure Restaurant & Bar Inc., Allure Restaurant & Bar, 2112 Flatbush Avenue, 11234, and Hudson River Yacht Club Inc., N/A, 2101 Bergen Avenue, 11234. Board Member Greg Borruso made a motion. Board Member Jim Buchanan seconded the Motion. The Motion passed with 34 Yes votes.

Natalie Aidinov, Representative for Verdure Inc., TBD, greeted everyone and voiced support for C'Zen Restaurant.

There being no further comments Chairperson Hernandez asked for a motion that Community Board 18 table the SLA Application received from Blueprint 265 Management LLC C'Zen Restaurant, 4410 Avenue H, Board Member Frank Seddio made a motion. Board Member Sal Calise seconded the Motion. The Motion passed with 34 Yes votes.

There being community opposition, Chairperson Hernandez asked for a motion that Community Board 18 recommends denial of SLA Application received from The Juicy Box Bar LLC, The Juicy Box, 2281 Nostrand Avenue, 11210. Board Member Frank Seddio made a motion. Board Member Sal Calise seconded the Motion. The Motion passed with 33 Yes votes.

OPEN DISCUSSION

Michael Benjamin, Representing State Senator Roxanne Persaud's Office greeted everyone and provided updates and community events. He stated that CB 18 meetings are our town hall and the way our communities come together to discuss issues. He wished a Happy Kwanza, Happy Hanukkah, Merry Christmas and a Happy and Healthy New Year to all.

Saye Joseph, Representing Council Member Mercedes Narcisse, stated that the Quentin Road meter proposal happened before the Council Member took office. The Council Member takes all concerns very seriously and contacted the NYC Department of Transportation, along with District Manager Sue Ann Partnow and Frank Seddio to make sure that we come to a collective solution. The Council Member's office is checking to see if there is a policy that requires the NYC Department of Transportation to notify a community before implementation of a proposal. If not, the Council Member will consider potential legislation to make sure there is a process that requires community engagement before any proposed installation. She also provided updates and information on their holiday toy drives and giveaways, community events, office address located at 5827 Flatlands Avenue and wished everyone a Happy Kwanza and Merry Christmas.

Yolette Toussaint, Representing Assembly Member Helene Weinstein, 41st A.D., Pastor Zack Martin, Representing Brooklyn Borough President Antonio Reynoso, Vivienne Bent, Representing Assembly Member Monique Chandler-Waterman, 58th A.D., Judith Destin, Representing Kings County District Attorney Eric Gonzalez's Office greeted everyone and provided information on programs, updates, upcoming community events, and extended Holiday wishes.

Board Member David Price greeted everyone and stated that recently the Board Members received a list of the Standing Committees. He proposed that a Standing Audit Committee be added and explained why he feels an Audit Committee would be beneficial to the Community Board. He made a motion to amend the Bylaws to add a standing Audit Committee. Board Member Elaine Reid seconded the Motion. Board Member Frank Seddio asked why we would need an Audit Committee. Board Member David Price explained that an Audit Committee provides oversight over many things besides just the financials. Board Member Barbara Bieber said that the OMB and the NYC Comptroller's Office audits us. Board Member Barbara Bieber provided Community Board 18's Financial Budget Report totaling \$257,057., minus personal services such as annual salaries \$197,486., minus other personal services in the amount of \$1442. leaving an unencumbered budget balance of \$58,128.20. She also stated this budget is what the city gives this Community Board and OMB and the Comptroller's Office handles the audit reports for the board. Board Member David Price asked that we move the discussion because the motion was made and requires a vote. A discussion ensued about having a quorum for enough votes. Board Member Victoria Stennett asked for clarification on the motion that was made by Board Member David Price before we go into the amendment. Board Member Frank Seddio made a motion to table the motion made by Board Member David Price until the January Meeting. Board Member Michelle Sealey seconded the motion. Board Member Naomi Hopkins asked how many voting members were present because we use Robert's Rules of Order. The amendment to table the Motion passed with 19 Yes, 10 No, 2 Abstention votes.

Robert Spieler, Area Resident requested more pickle ball courts in local parks and a comfort station in Jacob Joffe Park.

Noreen Medas, Representing Rockaway Parkway Merchants Association greeted everyone and provided information on programs, updates, and upcoming community events.

Board Member Denise Gordon asked for a motion that the board member emails be available to all board members. Board Member Joshua Fassu seconded the motion. Board Member Frank Seddio stated that there is a reason why the Brooklyn Borough President's Office does not give out the board members emails. There was a discussion between board members about the dangers of giving out their personal emails. Board Member Naomi Hopkins stated we should come to a consensus without taking these drastic measures and putting motions on the floor. Board Member Frank Seddio agreed. He suggested that Board Member Denise Gordon withdraw her motion and DM Partnow put together a method where each Board Members can choose whether or not they want to provide their emails to other Board Members. Board Member Denise Gordon agreed and withdrew her motion. Board Member Victoria Stennett agreed emails should be shared.

There being no further business or discussion, Board Member Violine Roberty made a motion to adjourn the meeting of Community Board 18. Board Member David Price seconded the Motion. The motion passed with 31 Yes votes. The meeting was adjourned at 10:09 P.M.
