**REGULAR MEETING**

A quorum was present to begin the meeting.

Chairperson Naomi Hopkins asked if there were any additions or corrections to the minutes of the Regular Board Meetings held on March 20, 2024. Board Member David Price made a motion that the minutes be accepted. Board Member Jamaal Carryl seconded the motion. The motion passed unanimously.

**PUBLIC HEARING**

Chairperson Naomi Hopkins introduced Library and Education Chair Sallie Bennett who gave a summary of the redesign presentation of the Canarsie Library which has been located at 1580 Rockaway Parkway since 1960. Thanks to funding from Councilmember Mercedes Narcisse, the Library will be getting a facelift. The library will have brand new amenities such as a teen lounge, children's area, community meeting room, new bathrooms and an additional second floor. Chair Sallie Bennett asked that we move to accept the Canarsie Library Redesign Proposal as presented. Board Member Adryanna Holder seconded the motion. 2<sup>nd</sup> Planning & Zoning Chair Tomas Hernandez stated that doubling the size is a concern and made a motion to table the vote for the Redesign of The Canarsie Library until the Planning and Zoning Committee can investigate it further. Board Member Andrenia Burgis seconded the motion. Chair Hopkins asked for a roll call vote and reminded everyone that a 2/3's vote is needed to table. The motion did not pass with 1 Yes, 16 No and 5 Abstention votes recorded. Area resident Harold Jones informed everyone that there were no

zoning issues, and the proposed design was “as of right”. There were questions from Board Members and community guests which were answered by Canarsie Library Branch Manager Alexander Tritiak and Karl Henry St. Cyr, Project Manager about the proposed redesign. Library & Education Committee Chair Sallie Bennett repeated her prior motion to approve the Canarsie Library Redesign Proposal, which was previously seconded by Board Member Aryanna Holder. The motion passed with 26 Yes votes recorded.

Chairperson Naomi Hopkins explained that when a vote is taken, it is her privilege to vote or not vote, maintaining impartiality. She will vote if there is a tie.

### **GUEST PRESENTATION**

Chairperson Naomi Hopkins introduced Megan Kleinman, Representing Interborough Developmental & Consultation Center (IDCC) who provided a brief presentation on their plans to establish a new NYS Office of Addiction Services and Supports at their 1285 Rockaway Parkway location. The outpatient clinic will be part of a building expansion making services such as mental health, care coordination, maternal and mental health, primary care, and addiction treatment more available and accessible.

Chair Hopkins introduced Council Member Mercedes Narcisse who greeted everyone and thanked the Board Members for their unanimous Yes vote for the redesign of the Canarsie Library which is an important project to her and everyone in the community. She also thanked Megan Kleinman for her work and all the professionals at the Interborough Developmental & Consultation Center for bringing much needed services to Canarsie and the surrounding area. Council Member Narcisse provided updates on future events and programs that she offers in her office. She reminded everyone that they need to work together and support each other.

Chairperson Naomi Hopkins introduced Council Member Farah Louis who greeted everyone and brought greetings to those that observed Ramadan and hoped they had an easy fast and wished those that will be observing Passover, a blessed holiday. She provided information about upcoming programs and events. Council Member Louis gave a shout out to Interborough Developmental Center and their work with mental health. She spoke about women’s defensive classes, crackdowns on illegal smoke shops, the ongoing construction of the B82 Select Bus Service along Kings Highway and her meeting with MTA and the effect of the Interborough Express on the district.

**COMMUNITY BOARD 18 APRIL CABINET MEETING**

**DDC** – The construction for the B82 Select Bus Service along Kings Highway is continuing with the next phase - breaking up the medians and pouring concrete for newer safe ones. There will be lane closures for vehicle & pedestrian safety. The DDC is working to avoid water shutdowns, especially during the Passover Holiday. They will be meeting with the 2 hospitals along Kings Highway to coordinate shutting down the water to replace the 100-year-old system.

**63<sup>rd</sup> Pct.** – Car break ins on the rise. Protest on Sunday, April 14<sup>th</sup> gathering at 12:30 pm at Kimball Street & Avenue U and marching to Kings Plaza. There will be street closures all around Kings Plaza and the Pct is advising you to avoid the area. NCO's working with Sanitation to tow vehicles and crack down on scooters. The next 63<sup>rd</sup> Community Council meeting will be held on April 24<sup>th</sup> at the Purpose of Life Church 1895 Flatbush Avenue at 7:00 pm.

**69<sup>th</sup> Pct.** – Sector A Build A Block meeting will be held on April 18<sup>th</sup> at 7:00pm at Holy Family Church. NCO's working with Sanitation towing abandoned and illegally parked vehicles. The next Community Council Meeting is April 30<sup>th</sup> at 8:00 pm at the HES. The Community Council will also be holding their Gala on May 6<sup>th</sup> at 7:00pm at Liberty Hall.

**DOB** – Department of Buildings launched its new education and outreach campaign, “**Get Summons Corrected**” (GSC). The goal of the campaign is to get more summonses certified as corrected by increasing the public's awareness of the need to certify correction and educating them on the process of certifying correction. The Department would like to introduce the campaign to homeowners, new home buyers, and other stakeholders who are undoubtedly impacted when a summons is issued or remains unresolved on a property. The outreach LINK was sent out to all of distribution lists and the information appeared on the

Website. The virtual meeting was held this afternoon and I hope it was helpful for many.

**Sanitation** – There will be extra trucks and shifts during the Passover Holiday. Sanitation requested cameras at Hendrickson Street between Avenue V & Hendrickson Place due to garbage dumping and boat trailer dumping. A request was sent to DOT by the Community Board office.

Tenequa Strong representing Senator Roxanne Persaud, Anastasia Yaskova Mayor's Community Affairs and Sabrina Dieujuste representing Councilmember Farah Louis gave updates on events and programs offered to the community.

### **IN & AROUND CB 18**

Additional traffic signals will be installed at the intersection of Ave D & E. 89<sup>th</sup> St.

Mill Island Civic President Ike Sinesi and I did a walkthrough in Mill Island with DOT to highlight the safety issues on the severely curved streets asking for street signs to identify the upcoming curve. DOT Borough Engineers conducted a study for curvature in the road and said it did not meet the warrants for Curve Warning signs.

### **COMMITTEE REPORTS**

**TREASURER'S REPORT** – David Price

Treasurer David Price began his update on the status of the social media and website contract. Timing was a concern, but there is no update on that contract. Two new contracts, one for signage and one for an exterminator were approved but not through the budget committee or Board Members. The Budget Committee cannot confirm if proper procurement took place with at least 3 different bidders. We cannot confirm if the bids were awarded to certified minority or women owned businesses, or if there are conflict of interests or disclosure forms obtained. These 2 contracts were valued at \$3350 and office supplies and snacks were \$3350. Some of the \$24,000 budget that I previously spoke about has been allocated to address some of these costs, leaving approximately \$17,000 of which \$15,000 has been promised to a vendor. A buffer of approximately \$2,000 will be left for CB 18 unless additional monies are spent between now and June. I think that CB 18 should adopt new procedures for the role of Treasurer. Chair Hopkins added that Treasurer is a brand-new position and that there will be an Executive Meeting in May to address rules, regulations, and procedures. The CB 18 office follows practices set forth by DCAS, Borough Hall and OMB.

Chairperson Paul Curiale explained that the Adult-Use Retail Dispensary Premises License Applications received from Fireleaf, LLC, 2102 Ralph Avenue, 11234, and Steven Etienne, Nycecity Corp d/b/a Society House, 2441 Flatbush Avenue, 11234, came before the committee on Monday evening. Both ownerships have their cards already and believe the card is spelled Courd. As Courd holders, it means they have their license in hand. We're not voting on the license; we're voting on the premises that they've chosen. Chair Curiale introduced the applicants. Chair Naomi Hopkins thanked the owners for coming, since this is the first time that we're hearing people are licensed before appearing at the Community Board. Again, she wants to commend Chair Curiale and Co-Chair Jamal Carryl on the work they have been doing on this committee. Chair Curiale is also arranging a cannabis info session with Floyd Jarvis since many of us are not familiar with cannabis and the cannabis industry. Chairperson Curiale asked for a motion that the board recommends approval the Adult-Use Retail Dispensary Premises License Application received from Fireleaf, LLC, 2102 Ralph Avenue, 11234. Board Member Tom Hernandez made a motion to approve the application. Board Member Valerie Woodford seconded the motion. The motion passed with 24 Yes, 2 No, and 2 Abstention votes recorded. Board Member Jamaal Carryl shared that both properties are in business districts, and they have parking lots. That is one of the questions in the applicant's survey. Chair Curiale asked for a motion that the board recommends approval the Adult-Use Retail Dispensary Premises License Application received from Steven Etienne, Nycecity Corp d/b/a Society House, 2441 Flatbush Avenue, 11234. Board Member Michelle Sealey made a motion to approve the application. Board Member Gardy Brazela seconded the motion. The motion passed with 23 Yes, 2 No, and 2 Abstention votes recorded. Chair Hopkins thanked the owners for coming. We appreciate business owners seeking licenses who are licensed and not operating illegally. There are so many rules that need to be followed and she trusts that all of you gentlemen will be good stewards in our community.

Representing State Senator Roxanne Persaud, 19<sup>th</sup> S.D. greeted everyone and provided information, programs, and upcoming community events.

### **NEW BUSINESS**

Jonathan Marable, Brooklyn Chamber of Commerce Small Business Resource Network greeted everyone and shared information on their hybrid event on April 24<sup>th</sup>, which is about the process for getting a cannabis license.

Dr. Jackie Cody greeted everyone and informed the board that the governor has signed bills into law, stopping unnecessary foreclosures and deed thefts. There will be a city-wide event at The Boys and Girls High School this Saturday at 10 o'clock with Supreme Court Justices and attorneys. The New York State Education Department came up with a Mayoral control report about the city-wide leadership team. The next summit is May 14<sup>th</sup>. She asked what can be done when a block in CB 18 keeps getting denied for a speed bump. The community board spoke about getting more young people involved and someone asked about teaching young people how to vote. She would like to help teach young people about civic engagement. Chair Hopkins answered the question about speed bumps and explained about the DOT study and formula they follow. We are anticipating that DOT will be a guest speaker at one of our upcoming meetings as per a request from our board. There is a possibility it will not take place in June. A resident stated that June 11<sup>th</sup>, 12<sup>th</sup>, and 13<sup>th</sup> are holidays. Chair Hopkins stated that they will announce the June meeting date at the May meeting. A special Town Hall meeting is also being arranged with the DEP. There are so many issues with flooding, sink holes and homes that are sinking throughout Community Board 18 that this Town Hall is going to happen. We need 100% of you here to show DEP and we need them to take this seriously.

There being no further business or discussion, Board Member Violine Roberty made a motion to adjourn the meeting of Community Board 18. Board Member Terri Cadet-Donald seconded the motion. The motion passed unanimously; the meeting was adjourned at 10:01 P.M.
