Chair Anthony Buissereth read the agenda into the record. He gave his remarks on the shootings in the district and thanked everyone who participated in the "We Are Bed Stuy" event.

District Manager Henry Butler announced his resignation after ten years on the job. He invited everyone to the Macon Street (between Patchen & Ralph Avenues) Annual Evening of Jazz on July 11th, at 6:00 p.m.

An Informational presentation was given by David Espinoza about the services provided at the Dr. Betty Shabazz SUNY ATTAIN Lab. The lab is located at 700 Gates Avenue. The program is funded by the City, and it provides classes in Microsoft, QuickBooks, food safety, Rosetta Stone in 24 languages, math. The program also provide workforce development. Classes are held hybrid or online.

The second Informational presentation was given by Jennifer Zisler, Assistant Principal at Clara Barton High School for Health Professions. The school offers an alternative career and technical educational (CTE) program in the following fields: medical assistant, nurse assistant, dental lab tech, vision care, and dental assistant.

There were three public hearings:

1. IN THE MATTER OF an application submitted by Izzy Rosenbaum pursuant to Sections 197-c and 201 of the New York City Charter for an Amendment to the Zoning Map, Section No. 16c:

A. changing from an M1-1 District to an R7D/C District property (C220453ZMK) bounded by Myrtle Avenue, Spencer Street, and Walworth Street; and

B. to create a new Mandatory Inclusionary Housing Area (N220454ZRK) to facilitate a new 8-story mixed-use building, including 54 dwelling units, at 703 Myrtle Avenue in Bedford-Stuyvesant, Community District 3, Brooklyn.

Richard Lobel,, Alexia Landesman and Haley Padgett were in attendance for presentation. He stated that this building will be an 8-story, 54-unit building, 18 of which will be permanently affordable. There will be 11 parking spaces and 28 bicycle spaces. The FAR is 5.6 with an AMI at 80% providing 1-4 bedrooms. 29 units will be 2 bedrooms, 25 units will be 1-bedrooms and 6 units will be 3-bedrooms.

The menu for lunch ranges from \$10.95 - \$14.95 and dinner ranges from \$14.95 - \$19. It will be authentic Thai cuisine with teas and bubbles. The hours will be 11:00 a.m. -10:00 p.m. Friday to Saturday.
