The meeting was called to order by the Chair Anthony Buissereth. He read the agenda into the record and gave his remarks. He reminded everyone that the real work of the Board is done at the committee level and invited residents to join a committee.

An Informational presentation was given by Dr. Adeniyi Olabumuyi and Dr. Elizabeth Jalkut, Woodhull Hospital on stroke prevention and care. Dr. Olabumuyi stated that stroke is the leading cause of death in the United States. There are 750,000 strokes per year and one stroke every 45 seconds. Factors that increase the risk include high blood pressure, diabetes, high cholesterol, and excessive drinking. There are ways to help reduce the risk by reducing alcohol intake, maintaining a healthy weight by exercising, controlling blood pressure, diabetes, and cholesterol. Ideally a person pressure should be 128/80.

A public hearing was held on the proposed street co-naming of Halsey Street between Bedford and Nostrand Avenues to Nelson M. Stoute Way. Veronica Lewis, the mother of Nelson Stoute presented a brief history on all the advocacy he did in the community up until his death in 2017. She stated that he was instrumental in getting the Nostrand Avenue Reconstruction, the Utica Avenue Elevator, and the newly designed District 3 sanitation garage.

There were no questions since everyone were familiar with the work that Nelson Stoute did in the community.

The second public hearing was held by Guy Fouyalle, owner of Brooklyn Taste Bar LLC who requested a letter of support for a State Liquor Authority License at 1803 Atlantic Avenue between Buffalo and Rochester Avenues. He stated that he previously owned Brown Chocolate Café for ten years and Jelani Lounge both on Fulton Street. He owns Tina's Place. He added that he works for New York Presbyterian Hospital where he in charge of catering.

Mr. Fouyalle stated that the establishment on Atlantic Avenue will provide a space for chefs and bakers to showcase their talent and build their brand. He will provide two tastings on weekends and will be open from Wednesday to Sunday between the hours of 6:00 p.m. - 9:00 p.m. The capacity is for 25 to 30 people.

The Awkward Scone (d/b/a Ursula) also requested a letter of support for a State Liquor Authority License at 387A Nostrand Avenue between Madison Street and Putnam Avenue. The owner Eric See gave the presentation. He stated that Ursula is named after his grandmother. It will be a full-service restaurant.

He currently have a staff of nine (9) at 724 Sterling Place where he has been since September 2020. He hopes to increase to 15. The hours of operation will be 8:00 a.m. - 11:00 p.m., 7 days a week. He will also utilize the backyard with seven (7) tables and fourteen (14) seats. The capacity of the restaurant is 24 with 10 seats at an open kitchen counter and 7 seats the bar.

Community announcements were made by the following people:

- Eddie Gajadar announced the grand opening of the African Art Museum at 1360 Fulton Street, 2nd floor featuring Eric Edwards collections more than 3000 artifacts. It is tentatively scheduled for February 20th.
- Gregory Anderson informed that Bridge Street Development Corp. will host an Information Session on January 18th, to discuss the Open Street application for Tompkins Avenue. The meeting will begin at 6:00 p.m. at Restoration Plaza.
