The meeting was called to order by the Chair Anthony Buissereth. He read the agenda into the record and gave his remarks.

There were two Informational presentations. The first presentation was given by the Budget Coordinator, TJ Wilson on the Capital & Expense Budget Requests for the Fiscal Year 2024 Preliminary Budget. She gave a brief synopsis on the roadmap to the budget process.

She highlighted the top five (5) priority Capital Request out of the 25:

- 1) More affordable housing for medium income households
- 2) Roadway maintenance (i.e., pothole repair, resurfacing, trench restoration, etc.)
- 3) Renovation of St. Andrew's Playground (partially funded)
- 4) Other capital budget request for DEP target flood resilience and storm water management investments
- 5) Affordable housing programs (NIHOP)

The top five (5) priority Expense Requests are:

- 1) Provide more enhance rental subsidies programs
- 2) Increase enforcement of dirty sidewalk, dirty area, and failure to clean area laws
- 3) Animal and pest control request including rat and mosquito populations
- 4) Create or promote programs to de-stigmatize substance misuse and encourage training
- 5) Improve enforcement and strengthen outreach and awareness to owners and residents from deed fraud

There will be a Public Hearing on February 9<sup>th</sup> to get feedback from residents before the deadline to submit the response by February 15<sup>th</sup>.

The second presentation was given by Cherine Anderson, Brooklyn Transition & College Access Center (TCAC) Ms. Anderson stated that there is a program in every borough. The Brooklyn program is located in Boys & Girls High School, 1700 Fulton street, 1<sup>st</sup> floor. The program supports high school students ages 14-21 years with Individualized Education Plan (IEPs). Some of the programs they offer are:

- Training Opportunity Program (TOP) is a 15-hour Internship in the fall from October to May
- Summer Youth Employment Program (SYEP) is a 6-weeks program from July to August which pays \$15 per/hour for 25 hours a week
- Pre-Employment Transition Services (Pre-ETS) free program done virtually, after school

- A. Bed-Vyne Brew LLC located at 370 Tompkins Avenue. The co-owner Rotimi Akinnouye stated that the business is expanding its liquor license to provide outside opportunities such as special events. The have been open for nine years.
- B. Martha's Cocina Mexicana LLC located at 338 Franklin Avenue. Owner Cindy Huesca stated that she have been opened since October. This is a Mexican restaurant with full-service. She offers brunch, lunch, and dinner. The hours of operation are 10:00 a.m. 11:00 p.m. Monday to Friday the bar will close at 10:00 p.m.

There will be one full-time manager, one chef, three helpers and one bartender. She is always in site except for Wednesdays. The capacity of the restaurant is 30 seats with seven at the seven bar stools.
