Community announcements were made by Coach Yasim about the celebration of Jackie Robinson on April 15th. Rev. Cynthia Niles, Raphael announced the opening of the comic bookstore at 831 Nostrand Avenue.

IN THE MATTER OF a private application submitted by Joel Berkowitz pursuant to Section 197-c and 201 of the NYC Charter for an amendment of the Zoning Map. Section No. 13b from M1-2 to R7D/C204 and a zoning text amendment to facilitate the development of a new 9-story, 41-unit mixed use building, including 12 units of inclusionary housing, with 41,929 sf of residential and 7,919 sf of commercial at 712 Myrtle Avenue.

- 2. We recommend that the already housed tenants should be given the opportunity to return when the building is complete.
- 3. We recommend MIH Option 1
