First Roll Call:

There were 24 members present and 26 absent.

Informational Presentations:

• TJ Wilson shared insight into the process of gathering input for the FY 2026 Budget. Surveys were distributed for residents to submit their concerns/issues which will be used to compile the top needs of the district. This allows residents to participate in the budget process and determine how

funds are distributed in the community. There will be a public hearing on Monday, September 30th at 6:30 p.m. The deadline to submit the district needs is Thursday, October 31, 2024.

• Etienne Eaton, Director, Fort Greene Council, Inc. informed residents of the programs that are being offered for seniors 60 years and older. The program was started 50 years ago by Sam Pinn. They currently have14 clubs throughout Brooklyn which offers physical fitness, Zumba, Tai Chi, chair yoga. All clubs have a gym. They have also partnered with the District Attorney's office to offer tech classes.

There were 33 members present and 17 absent. There was quorum.
