Mr. Smith informed the audience that he was returning from a hearing regarding co-locations and closing of schools in District 16. Assembly Member Robinson has met with the school Chancellor and the former superintendent regarding this issue. There is an Acting Superintendent now. District 16 is being targeted as a failing district.

DISTRICT MANAGER'S REPORT - Henry L. Butler

Mr. Butler informed the audience about a Public Hearing concerning the proposed development of the Woodhull parking lot to house adult with mental health. The hearing will take place at NYC Health and Hospitals, 125 Worth Street, Room 519, on January 7th, at 6:00 p.m.

I. INFORMATIONAL PRESENTATION

A. Health & Social Service Committee:

The NYC Department of Health will discuss the 2015 Community Health Profile Report Edna Johnson, Committee Chair introduced Torian Easterling, MD, MPH, Assistant Commissioner of Department of Health & Mental Hygiene (DOHMH)

Dr. Torian Easterling gave a PowerPoint presentation on the Community Health Profile 2015 for Bedford Stuyvesant. He highlighted some of the health disparities in the community such as premature immortality, diabetes. The study looked at how poverty limits health and healthy life styles, housing, economics and social conditions affect the outcome of health. They are looking at healthy living.

The DOHMH compared 4 community districts: Brownsville, East New York, Bushwick and Bedford- Stuyvesant. These community shows very poor outcomes. A. Economic Development Committee:

Alcohol Beverage Control License Application request for a letter of support, by 382 MGB Inc., located at 382 Marcus Garvey Blvd, between Jefferson and Hancock Streets. Richard Flateau, Committee Chair introduced Frank Moe, Owner and his representative Anthony Caraballo

Mr. Caraballo stated that Mr. Moe is an experienced operator. He has owned and operated a business at Rope, 415 Myrtle Avenue from 2003-2012 and Hot Bird, 825 Atlantic Avenue since 2010. He recently purchased a Town House two blocks away.

This is a small operation. He will most likely have three employees. The hours of operation will be from 5:00 p.m. - 2:00 a.m., 7 days a week. A PowerPoint was shown. He provided a letter of support from the District Manager of Community Board 2, Robert Perris. There will be 7 tables with 20 seats/stools. The capacity is 74.

Questions and Answers

Christopher James: Is this a bar or restaurant? **Frank Moe:** It is primarily a bar however, sliders will be served.

Demetrice Mills: Why are you moving so much? **Frank Moe:** When the lease expires, the rent is raised or the lease is not renewed.

Tywan Anthony: How will you manage the crowd from the men shelter? **Frank Moe:** Everyone is welcome. I don't anticipate any issues.

Michael McCaw: Is the building vetted? Is this a commercial space?

Frank Moe: We will get a letter of No Objection from the Department of Building. There is no C of O.

Anthony Caraballo: He will not be able to get a license without the DOB approval. The architect is not here to speak to this.

Ryan Joseph: What will the community gain, the hipsters are treated better at some of these new places.

Frank Moe: He reiterated that everyone is welcome. We don't treat people differently.

Mary Jemison Head: Did you speak to the churches in the area? **Frank Moe:** I am aware of the churches. We have a good relationship.

Santina Payton: Is this cash only? **Frank Moe:** Yes, it is a small operation.

B. Economic Development Committee:

Alcohol Beverage Control License Application request for a letter of support by Brooklyn A Hotel, located at 1199 Atlantic Avenue, between Bedford and Nostrand Avenues. Richard Flateau, Committee Chair introduced Meyer Bodher, Owner and Melinda Park, General Manager.

Ms. Park stated that this is an Independent Boutique Hotel four floors, 34 guest rooms. There are 6 guest rooms on the first floor, 8 on the second and third floors and 12 on the fourth floor. The rooms range from standard to junior suites.

She explained that Meyer Bodher owns the hotel however, it is managed by Rio Hospitality Group, her employer. They have been open for three months with 8 full-time employees, 2 part-time employees. Some from the local area. They plan to open a bar in the lobby area for the guest. The hours of operation will be 5:00 p.m. - 11:00 p.m., 7 days a week.

A PowerPoint was shown highlighting the interior of the hotel. Ms. Park stated that there are 12 different wallpaper showcasing various areas of Brooklyn. The junior suite is 440 sq. ft. The owner introduced himself to the audience. **Ouestions and Answers**

Ryan Smith: Why did you choose this location and what are the rates? **Melinda Park:** The rate ranges from a low hundreds to 400 hundreds depending on the room. They also have government, AAA, and AARP rates Meyer Bodher: We have owned the building for 10 years as a warehouse.

Michael McCaw: Do you have other hotels in the City and are you affiliated with any entities that owns hotel? Do you have a contract with the Department of Homeless Services? **Melinda Park:** No, this is his first hotel which is why he hire us.

Kimberly Hill: Will you have community space available? **Melinda Park:** In the lower level we have 1 meeting room for rent. It is about 1400 sq. ft. Her email is <u>Melinda.park@thebrooklynny.com</u> or visit the website at <u>www.thebrooklynny.com</u>

The proposed scope of the project is to install a new roof bulkhead, demo and renovate the interior, replace the windows in the front and rear façade, renovate the rear façade, remove an existing mudroom extension, add a new exterior deck and stairs at the rear and add two more bathrooms.

The Committee voted unanimously NO on the application for the installation of a bulkhead structure and deck railings on the roof of the property.

Mr. Mills reported that there was a meeting with HPD and the Parks Department regarding the gardens which will be development for housing. He reported that 34 of the 43 property that HPD owns will be saved. 27 gardens in Brooklyn were saved, 6 of which are in Bed-Stuy.

Dr. Bernell Marcus

He discussed the issue of DOT installing islands on Eastern Parkway as a way of eliminating the West Indian Day Parade. He asked that residents should Interfaith Hospital. A new Black CEO was recently appointed. In addition, he stated that 4 schools are slated to be closed in Bed-Stuy including Boys and Girls High School.
