- Reasonable Suspension that You have a weapon
- Search is then conducted

  - 1. Ask the Question clearly—Am I free to Leave? If the Officer Answers No. You are being temporarily detained.

## **Question and Answer**

## After the face to face is done, what happens next?

Mediation is not on Police Officer Records. If you are displeased, you can send it back to CCRB. Note. Face to Face is voluntary by the officer. Additionally, you can always call back into the office for follow-up.

## Sylvia Ancruu – Director of CCRB

Advised she cannot comment on pending investigations. Must be filed by observer to file and provide as much information.

## **Resident Question and Statement**

Why are Community Affairs Officers Changing? It is good for the community that they stay their post. Our Community Officers are knowledgeable and we want them to stay.

## CCRB Guidelines

- d. CCRB General Info
  - 1. The CCRB will record, investigate and mediate. Acting also as an information deposit to see data trends.
  - 2. 100% of complaints filed involve 14% of Officers. CCRB finds face to face mediation to be successful.
  - 3. If there is an incident of Police Officer Retaliation, it will be flagged as such.
