DISTRICT MANAGER’S REPORT – Henry L. Butler

Mr. Butler informed the audience that the June 6th meeting will be held at the Brooklyn Job Corp., 585 Dekalb Avenue (corner of Nostrand Avenue).

He gave an update on a meeting with DOT on their plans for the Utica Avenue and Fulton Street Intersection. A walk through was done by him and Mr. Stoute. He explained that the area needs to be ADA accessible. The solution is to expand the island in order to create a ramp. The turn lane will remain but it will be narrow. DOT will be present at the June Transportation, Sanitation & Environment Committee meeting.

In addition, Local Union 1199 SEIU and NYSNA will host a Job Fair at Interfaith Medical Center on May 7th, from 9:00 a.m. – 12:00 p.m.

I. PUBLIC HEARING

A. Economic Development Committee:

Chez Oskar is seeking a letter of support for a change of address for their Alcohol Beverage Control License

Richard Flateau, Committee Chair introduced Charlotta Jansen, Owner

Ms. Jansen stated that she has been in business for 17 years. She has started construction on 310 Malcolm X Blvd and is expanding to 373 Decatur Street. She is requesting to move the liquor license. Everything stays the same, it will 100 feet along Malcolm X Blvd and 17 feet along Decatur Street. This is a restaurant not a bar.

Questions and Answers

Gregory Glasgow: Will you be changing the entrance from Malcolm X Blvd to Decatur Street, why are you changing the address?

Charlotta Jansen: The entrance will remain on Malcolm X Blvd, the location of the bar is what is being changed. It is being expanded to Decatur Street but there is no entrance on Decatur Street. The entrance on Decatur Street is for the upper floors.

Resident: How many people will you employ?

Charlotta Jansen: Hopefully 15-18, depending on the season.

B. Economic Development Committee:

Captain Dan's Good Time Tavern is seeking a letter of support for a Sidewalk Cafe License

Richard Flateau, Committee Chair introduced Carmen Melo and Adrian Dowd

Captain Dan's Good Time Tavern is located at 497 Greene Avenue corner Nostrand Avenue. This is the second establishment they are operating together. The other establishment (The Anchored Inn) is located in Bushwick. It has been operating for five years. Captain Dan's is a restaurant and bar and they have been opened for four months.

The currently have 15 employees, all with exception of three reside within 10 blocks of the business. She anticipate hiring more if the sidewalk cafe permit is approved. Everything is made from scratch. The dining area seats 25. They plan to add 14 seats outside. Delivery service is now available. The café will be on the Greene Avenue side. She stated that legally in New York City a sidewalk café must close by Midnight on weekdays and 1:00 a.m. on weekends. However, they would like to stay open until Midnight on weekends and 11:00 p.m. on weekdays.

Questions and Answers

Joe Gonzalez: Who did you speak to from the block Association?

Carmen Mello: Tina and Vaughn from Greene Avenue between Nostrand and Marcy Avenues are regulars. They provided a letter of support for our liquor license and has verbally given their support.

Resident: The sidewalk was redone and this café will force people to go into the street, the cars drive by very fast

Carmen Mello: Legally we are required to have 8 feet accessible in order to qualify. The sidewalk is very wide.

II. INFORMATIONAL PRESENTATION

A. Education & Youth Committee:

The committee hosted an informational presentation on the roll out of the Gifted & Talented Program in school District 16

Oma Holloway, Committee Chair introduced District 16 Superintendent, Rahesha Amon-Harrison

Superintendent Amon-Harrison gave brief update on the Gifted and Talented Program. She stated that the program is for incoming 3rd graders. Recommendations are made in the 2nd grade. Parents can also make recommendations. It will be holistic rubric to determine eligibility. The program is slated to begin at P.S. 26 and in September 2017, a Middle School Gifted and Talented Program will begin. The teachers will be afforded an opportunity to become certified through a partnership with the New York Historical Society and Hunter College.

B. Civic & Public Safety Committee

The committee hosted an informational presentation by NYC Ceasefire.

Stacey Ruffin, Committee Co-Chair introduced Pradine Saint-Fort

Ms. Saint-Fort stated that NYC Ceasefire is a group violence intervention model. The focus is on group members. To help keep them alive and out of prison, to stop the violence. There is a partnership between law enforcement, social support services and the community to assist the members of a gangs, crews, and drug set.

C. Transportation, Sanitation & Environment Committee:

The committee hosted an informational presentation by the Brooklyn Movement Center (BMC) on ‘Here Comes Solar Program’

Nelson M. Stoute, Committee Chair introduced Jeremy Friedman, Organizer for BMC, Mark Winston Griffith, Executive Director and Angelica Ramdhari, Program Manager

Ms. Ramdhari stated that they are a non-profit solar purchasing initiative that is partnering with the Brooklyn Movement Center to bring solar resources to homeowners in Bed-Stuy and Crown Heights. This initiative relies on neighbors working together. A discount is provided when neighbors buy in bulk. She did a PowerPoint. “Here Comes Solar” does a site assessment of the home to determine the cost. They will check the roof and the electrical system.

Mr. Friedman added that the cost of installing solar energy in homes has decrease significantly. He stated that people on a fixed income might be able to receive free installation. Some may qualify for zero interest loans which will help in getting City, State and Federal tax credits. There are other credits

available for historic districts, 20% discount when done with other neighbors. There is a 25 years warranty.
