Presentation on the services provided by Woodhull Hospital

Edna Johnson, Committee Chair introduced Maria Hernandez-Riccio, Director of Community Affair, Gregory Calliste, CEO of Woodhull Hospital and Anthony Di Vittis, Associate Director of Public Affairs

Ms. Hernandez gave an update on the services that Woodhull Medical Center provide to the community. She added that under the leadership of Mr. Calliste, Woodhull has become the hospital of choice. They provide healthcare regardless of immigration status, ability to pay and with dignity. Brochures were distributed outlining their services such as: asthma care, cardiology, diabetes, mental health, cancer, free health education, etc.

The hospital accepts most insurance plans and on Thursday, October 25<sup>th</sup>, they will host a "Health Insurance 101" workshop. On Thursday, October 4<sup>th</sup>, there will be a lecture on "Women's Cancer: Are You at Risk?" On Thursday, November 1<sup>st</sup>, the lecture will be on pancreatic cancer; on Thursday, December 6<sup>th</sup>, there will be cancer screenings and prevention

# A. Capital & Expense Budget Committee:

The Budget Coordinator held a Public Hearing on Community Board 3 Fiscal Year 2020 Budget Request

Richard Flateau, Board Chair introduced TJ Wilson, Budget Coordinator

Ms. Wilson gave a brief synopsis of some of the priority budget requests and the agency responses:

# ✓ Upgrade existing facilities for the homeless

**Request:** The rehabilitation of the Sumner Avenue Armory for Community Use, we request funding to conduct a feasibility study that would demonstrate the multifaceted usage of the Armory, which can include or exclude the current homeless program.

# ✓ Request: Roadway Maintenance (trench restoration)

- Hancock Street between Marcy and Tompkins Avenues was funded
- MacDonough Street between Malcolm X Blvd & Stuyvesant Avenue was not funded
- Jefferson Avenue between Stuyvesant Avenue & Malcolm X Blvd was not funded

# ✓ Request: Provide more housing for medium income households

The request was sent to HPD regarding the land at Saratoga Avenue and Fulton Street

**Response:** The agency will try to accommodate

# ✓ Request: Reconstruct or to upgrade a park or amenity (i.e. playground, outdoor athletic field)

The agency's response is that their funds is insufficient for this project and it should be brought to the attention of the elected officials

✓ Request: Conversion of Marcy/Kosciuszko Pool into a Year-Round Facility
The agency's response is that their funds is insufficient for this project and it should
be brought to the attention of the elected officials

✓ Request: Re-open the Bedford Avenue end of the Nostrand Avenue A & C Station

**Response:** The Board was told to contact the Transit Authority directly.

✓ Request: Construction of a catch basin on the Northeast and Northwest corners of Macon Street and Throop Avenue

**Response:** More information is needed before a funding decision can be made. **Henry Butler:** It was determined by DOT and DEP that this is not a catch basin issue. The tree trunk damaged the sidewalk therefore the water is not able to run off properly into the catch basin. The church is responsible for repairing the sidewalk.

# **B.** Housing and Land Use Committee:

IN THE MATTER OF an application submitted by 895 Bedford Avenue Realty, LLC Pursuant to Section 197-c and 201 of the NYC Charter for an Amendment to the Zoning Map, Section No. 17a:

- 1. Changing from an M1-2 District to an R7a District property bounded by a line 80 feet northerly of Willoughby Ave, Spencer Street, Willoughby and Bedford Avenues; and
- 2. Establishing within the proposed R7A District a C2-4 District bounded by a line 80 feet northerly of Willoughby Ave, Spencer Street, Willoughby and Bedford Avenues.

Dennis George, Committee 1<sup>st</sup> Vice-Chair introduced Eric Palatnik Esq., Legal Representative for the owners

Erik Palatnik stated that 895 Bedford Avenue is currently a gas station but it is presently under performing. They do not sell a lot of gas or fix a lot of cars. They are requesting a zoning change from manufacturing to residential, a R7 with ground floor commercial overlay. It will be a seven-story brick building with 36 units, 11 will be affordable under the Mandatory Inclusionary Housing Program (MIH). There will be 6000 sq. ft. of retail space.

There were discussion about jobs, parking and the increase in the affordable units.

# **Question & Answers**

**Dr. Debra Lamb:** How can you ensure that the occupants in the building will not only be Hasidic?

**Erik Palanik:** The developer is not Jewish and they are building this for the market needs.

**Henry Butler:** The Housing & Land Use Committee always require that the developer contact a local organization like Bridge Street Development Corp. Richard Bearak, Office of the Borough President and they will be voting on the application on Thursday, October 11<sup>th</sup>, at 6:00 p.m.

**Tywan Anthony:** What firm are you using for construction and the process and who will be managing it?

Alcohol Beverage Control License Application for the Bushwick Ale House, 1056-1058 Broadway between Malcom X Blvd and Hart Street

Tywan Anthony, Committee Chair introduced Louie Selamaj, Owner

Frank Nalevaiko gave a PowerPoint presentation. The owners, Louie Selamaj and his wife Alida Maioriano were also in attendance.

Mr. Nalevaiko informed that this will be an American Classic Diner style restaurant serving breakfast, lunch and dinner. The owner has opened three other businesses in the past three years: the Ridgewood Ale House on Myrtle Avenue, Bushwick Bagel House on Wyckoff Avenue and Maspeth Pizza House of the Long Island Expressway. The restaurant is currently open and they have held a license since 2011.

There will be 32 tables with 108 seats and 13 stools at the bar. There is a food counter for breakfast with 12 seats. The hours of operation will be seven days a week from 7:00 a.m. – midnight. A PowerPoint presentation was done highlighting the menu and the interior and exterior of the space.

**Resident:** It sounds like you are having a sports bar.

**Frank Nalevaiko:** Primarily we will be serving food and drinks, there will televisions with a sports bar atmosphere. Like Applebee's.

**Morgan Munsey:** Why the name Bushwick and not Bed-Stuy?

**Louie Selamaj:** I already had the sign made for another business in Bushwick but it fell through and it cost \$1700.

# **D.** Economic Development Committee:

Alcohol Beverage Control License Application from 566 Nostrand Avenue Inc., 566 Nostrand Ave between Herkimer Street and Atlantic Avenue

Tywan Anthony, Committee Chair introduced Michael Franklin Jr., the owner

A PowerPoint presentation was done. This will be night club. The hours of operation are 10:00 p.m. - 4:00 a.m. from Thursday – Sunday. There will be standup tables and chairs at the bar. It will have an open style buffet

He stated that according to the State Liquor Authority due to the "500 Foot Rule" there are three businesses within 500 feet: the Brooklyn A Hotel, 1285 Fulton Street and 608 Nostrand Avenue. They requested an official measurement but no one came. According to SLA map, they are 505 feet and 525 feet away.

He stated that the area lacks night life and he thinks that it will enhance the area. They have hired Heighten Security. There will employ 68 security guards including females and 32 cameras. There will be metal detectors and wands.
