 - i. Permits have been revoked. CB9 inquired about why permits were revoked.
- b. Court update for 40 and 54 Crown St
 - i. December 3 violation of TRO. Virtual court date
- c. Draft EIS Statement for 960 Franklin Ave Project
 - i. No response from DCP

3. New Business

- a. Bedford Union Armory Site
 - Contamination issue (asbestos) was holding up work at site. Warren Burke received correspondence that contamination issue has been resolved. Warren Burke to report back.
- b. 960 Franklin Ave Rezoning
 - i. FB sent correspondence
 - ii. Additional amendment submitted on 11/6. Questions about whether this restarts 30 day pre-certification timeline
