- 1. Meeting called to order by Chair Moses at 7:15pm
 - a. Committee members and meeting attendees introduced themselves
 - b. Nolan Levenson accepted the assignment as committee recording secretary and Warren Burke agreed to committee vice chairperson.

2. Old Business

- a. Patricia Moses gives overview of previous Land Use / ULURP meeting in March of 2020. The meeting was a training led by Richard Bearak, Office of the Borough President Eric Adams, who provided overview of ULURP process and role of community board and borough president in that process
- b. 54 & 40 Crown Street updates
 - i. Alicia Boyd provides history on rezonings and status of case
 - ii. Alicia Boyd requested that Community Board 9 resubmit its request for environmental documents for the project
- c. 960 Franklin updates
 - Alicia Boyd provides updates on the latest plans for 960 Franklin.
 Developer submitted new application in September 2020 with a revised number of buildings (2 instead of 5)
 - ii. On 2/3/20, the Land Use / ULURP committee passed a motion to request the site draft environmental impact statement. Mia Hilton agreed to submit a second request.

3. New Business

- a. 1015 & 1035 Washington Ave
 - i. September of 2020 CB 9 was informed that Sullivan Residences LLC applicant owner of 1 Sullivan Place, is constructing a new development with 49 units, including 11 dedicated affordable units for seniors. The project already has approved permits. The owners of 1 Sullivan also own 1015 and 1035 Washington Avenue and are planning on combining the lots.
 - ii. Discussion about ongoing construction at 1015 & 1035 Washington Avenue. Residents of 1035 Washington Avenue are concerned about the construction occurring in the adjacent lot at 1 Sullivan Place.
 - iii. Multiple residents in 1035 Washington Avenue, including Dorothy Green-Francis, Monica Palta, and Elizabeth Macken provided an overview of the issues. The primary concerns were:
 - Lack of communication from building owners about plans for construction
 - 2. Windows are being boarded up, and may potentially be blocked in the long term by new building
 - 3. Concerns about fire safety and egress both during construction and after building is completed
 - iv. Residents are asking that Community Board 9 follow up with DOB to ensure that the new building under construction meets all codes in addition to ensuring safe conditions during construction.
 - v. Warren Burke recommends that Chair Moses reviews issue with CB9 Housing Committee Chair Alejandra Caraballo since it is also a housing issue
 - vi. Esteban Giron says that he will be discussing the issue with DHCR commissioner next week and will report back
 - vii. Mia Hilton will reach out to DOB for more information

b. 169 Empire Blvd

- i. Discussion about permits files for new development 169 Empire. Plans call for an 80+ room hotel
- ii. Concerns were raised about why a new hotel would be constructed during a time when existing hotels are struggling due to pandemic. There is doubt about what the demand is for a hotel
- iii. Some members raised concerns that hotel will be utilized as homeless shelter
- 4. Chair Moses announced that next meeting will be on November 10 at 7pm
- 5. Meeting adjourned at 8:18pm
