Debbie Timothy, Economic Development – Committee discussed the issues facing small businesses in the community. They are in the midst of creating a directory of resources for small businesses. The committee is also working on Shop Local initiatives.

Francisca Leopold, Health and Social Services Committee – The committee met and discussed homelessness, mental health, suicide prevention and diabetes. Each month there will be a segment addressing specific health issues. A doctor from Kings County Hospital will be on hand at the General Board meeting to address concerns surrounding the vaccine.
