I. Committee Chair, Carmen Martinez called the meeting to order at 7:05 p.m.

- Empire Reconstruction Project Update, Alexandra Girgis, NYCDDC II.
 - a. Project received a time extension through Nov 2022 (was stated in four to Quarter 2021 Newsletter)
 - **b.** Contractor was working surface level activities on the east side at the end of 2021.
 - **c.** Due to the wintry weather and completion of the removal/relocation of utility interferences by ConEdison, operations moved the west end.
 - **d.** Sewer replacement operations are currently underway at the intersection of Franklin Ave & Empire Blvd.
 - e. Sewer and water main replacement on Franklin Ave b/w Empire Blvd & Sullivan Pl will follow, and require a temporary road closure.
 - **f.** Once permitted by DOT, road closure will occur during work hours of 9AM 2PM from Mon-Fri for approx. 4-6 weeks.
 - g. Road closure will also require parking restrictions; Community Advisories will be distributed for both.
 - **h.** Work on the east end is expected to resume with more consistently warm weather.
 - i. Pedestrian Safety

- 1. Contractor utilizes pedestrian barricades and signage to intermittently close crosswalks and portions of roadway where work is occurring. They also have flaggers directing pedestrians.
- 2. If a community member observes anything they find concerning, they can and should contact the CCL at 646-630-0464.

ii. Committee Member Concerns

- 1. Committee Member Paco Abraham inquired whether work would include the installation of bump outs which will enhance pedestrian safety but may impact the possibility of a future extension to the Empire Blvd bike lane from its current end point at Bedford Ave west to the park.
 - a. One bump-out will be installed at the northeast corner of Empire Blvd & Washington Ave for those pedestrians traveling south across Empire Blvd
 - b. One bump-out will be installed at the northeast corner of Empire Blvd & Franklin Ave for those crossing west across Franklin Ave.

 - i. Street restoration at the completion of the Empire Blvd reconstruction project
 - ii. Crosswalk installation at Sterling Street and Washington Avenue
