II. Old Business

- **a.** City of Yes Text amendments subcommittee update by Nichola. Per Chairman Baptiste:
 - i. We have yet to meet because we were informed changes had to be made to the subcommittee:
 - ii. the chair of a subcommittee has to be a board member and
 - iii. the members of the subcommittee must be a subset of the overall committee. Members of the public and other board members may attend but cannot be members of the committee.

For example it says that community board 9 neighborhoods have some of the lowest percentages of rent stabilized housing in Brooklyn, but the equitable development data explorer says 68% of our total housing units are rent stabilized, which is probably one of the highest percentages in the borough. Where is their data coming from? We should attend and review.

- **b.** Borough Hall ULURP training for community board members Dec 7 all board members should attend if possible because all board members have to vote on ULURP applications.
- c. Tom when are we going to discuss the report suki sent out about City of Yes
 - i. Pat you will discuss at the subcommittee meetings

- a. Theresa what is going to happen to **Tivoli Towers** since its falling apart
 - i. Mia emergency repairs are still ongoing and a few families had to be relocated. There was damage to the higher floors.
 - ii. Esteban willful negligence. CM negotiated an extension of the ML program but that expires next year
 - iii. Warren this issue should be raised at the housing committee. There could be a lot of people displaced if the building is condemned, it's very important although its not ulurp.
 - iv. Mia Crystal Hudson held an emergency meeting. There was an 8% increase in maintenance yet they cannot maintain the building
 - v. Felice says she knows the VP of tenants association there
 - vi. Pat says she wants to enter an official complaint and request that the VP from TT attend next meeting
- b. Jay how many committee members are from the southeastern part of the district?
 - i. Warren says he lives there
