## Open discussion on LinkNYC 5G Network Poles:

Residents continue to express concerns about the proliferation of the LinkNYC 5G wireless installations in Brooklyn Community Board 9 and the potential impact on residents' health. There are significant doubts about the safety of potentially widespread human exposure.

Following an open discussion on 5G at our April 3, 2023, meeting; the EPC members have questions about the timeframe in which information pertaining to LinkNYC proposal was presented to CB9 and what transpired during that time until now to make a favorable decision on behalf of the residents of the community that we represent as volunteers/advocates. - Did Brooklyn Community Board 9 receive any written information about the roll-out of the LinkNYC 5G Network?
- When was this written/verbal notice received?
- What were the details in the notice if CB9 did receive notification?
- Was the Chair of CB9 notified?
- Was the former Chair of the Environmental Protection Committee or any other committee notified?
- Was the community notified?
- If residents of CB9 community were not notified; why not?
- Did BK-CB9 community have any input in the 5G installation process?
- How many 5G Poles have been installed within Community Board 9?
- How many poles are pending installation?
- Is there a reason the ULURP process was not taken into consideration on this 5G issue before now?

\*\*\*\*If CB9 is unable to provide answers to the enclosed questions, the Environmental Protection Committee recommend a moratorium on the 5G installation process allowing the community to give input on the health concerns raised about 5G installations. \*\*\*
